




AFFIDAVIT OF NOTIFICATION

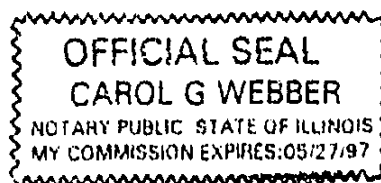
