Partial prepayment, other than on an installment due date, need not be credited until the next following installment due date or thirty days after such prepayment, whichever is earlier.

 - (II) interest on the note secured hereby; and
 - (III) amortization of the principal of the said note.

Any deficiency in the amount of any such aggregate monthly payment shall, unless made good prior to the due date of the next payment, constitute an event of default under this Mortgage. Adds the foll-wing provisions:

THIS LOAN IS NOT ASSUMABLE WITHOUT THE APPROVAL OF THE DEPARTMENT OF VETERANS AFFAIRS OR ITS AUTHORIZED AGENT.

The loan may be declared impediately due and payable upon transfer of the property securing such loan to any transferce, unless the acceptability of the assumption of the loan is established pursuant to section 3714 of chapter 37, title 38, United States Code.

- A. Funding Fee. A fee qual to one-half of 1 percent of the balance of this loan as of the date of transfer of the property s'all 1 e payable at the time of transfer to the loan holder or its authorized agent, as trustee for the Logariment of Veterans Affairs. If the assumer fails to pay this fee at the time of transfer, the fee shall constitute an additional debt to that already secured by this instrument, shall bear interest at the rate her ain provided, and, at the option of the payee of the indebtedness hereby secured or any transferce uncord, shall be immediately due and payable. This fee is automatically waived if the assumer is exempt under the provisions of 38 U.S.C. 3729 (b).
- B. Processing Charge. Upon application for exproval to allow assumption of this loan, a processing fee may be charged by the loan holder or its call orized agent for determining the creditworthiness of the assumer and subsequently revising the holder's ownership records when an approved transfer is completed. The amount of this charge and not exceed the maximum established by the Department of Veterans Affairs for a loan to which excellent 3714 of chapter 37, title 38, United States Code applies.
- C. Indemnity Liability. "If this obligation is assumed, then the assumer hereby agrees to assume all of the obligations of the veteran under the terms of the instrument's creating and securing the loan, including the obligation of the veteran to indemnify the Department of Veterans Affairs to the extent of any claim payment arising from the guaranty or insurance of the indebtedness created by this instrument."
