ORDINANCE NO. 94-0-54

AN ORDINANCE VACATING AN ALLEY IN THE VILLAGE OF WILMETTE, COOK COUNTY, ILLINOIS

WHEREAS, the President and the Board of Trustees of the Village of Wilmette, Illinois, after due investigation and consideration, have determined that the alley commonly known as the 20' wide unopened and unimproved east/west alley in the area north of Wilmette Avenue, between Leamington Avenue and Laramie Avenue, hereinafter legally described, are adjoined on both sides by private uses, has never been opened and will not be used by the general public as an alley and is no longer required for public use, and that the public interests will be subserved by vacating said parcel; and,

WHEREAS, in the opinion of the President and Board of Trustees, the relief to the public from the further burden of responsibility for said alley would be adequate compensation for the vacation of the alley hereinafter described;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Wilmette, Cook County, Illinois:

SECTION 1: That the alley hereinafter described is no longer required for public use and the public interests will be subserved by vacating said alley.

SECTION 2: That the heretofore dedicated alley, legalized described as:

ALL THE EAST-WEST ALLEY IN BLOCK 8 IN WILMETTE-LARAMIE SUBDIVISION, BEING A SUBDIVISION OF LOTS 42 AND 43 IN COUNTY CLERK'S DIVISION OF SECTION 31, TOWNSHIP 42

NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN (EXCEPT THAT PART OF LOT 42 OWNED BY C, & N.W. RY CO.); LYING WEST OF THE WEST LINE OF LEAMINGTON AVENUE AND EAST OF THE EAST LINE OF LARAMIE AVENUE; IN COOK COUNTY, ILLINOIS;

which said premises are shown on the attached plat, which plat for greater certainty is made a part of this ordinance, BE AND THE SAME IS HERETY VACATED AND CLOSED, as shown on said Plat of Vacation.

SECTION 3: A certified copy of this ordinance shall be filed by the Village Clerk of the Village of Wilmette, Illinois, for recording in the office of the Recorder of Deeds in Cook County, Illinois, within sixty days after the passage of this ordinance.

SECTION 4: This ordinance shall be in full force and effect from and after its passage, approval and publication, according to law.
