#### ORDINANCE NO: 2645

AN ORDINANCE VACATING A PORTION OF A CONSERVATION EASEMENT IN CRYSTAL SPRINGS SUBDIVISION IN THE VILLAGE OF ORLAND PARK, COOK COUNTY, ILLINOIS

WHEREAS, the Village of Orland Park (the "Village") has heretofore accepted dedication of a conservation easement over portions of Crystal Springs Subdivision, which conservation easement has been recorded with the Cook County Recorder of Deeds as document number 92-963119; and

WHEREAS, said conservation easement is an exhibit to the development agreement for Crystal Springs Subdivision, approved by the Village Board on November 23, 1992 by Ordinance 2305; and

WHEREAS, to appropriately locate the house desired by the owner of Lot 13 in Crystal Springs Subdivision and accommodate other easements on said lot, the southwest corner of the house encroaches on the existing conservation easement; and

WHEREAS, the portion of the conservation easement in the vicinity of the encroachment has been determined by the Village's Engineering Department not to contain floodplain, wetlands or any species of endangered plant life; and

WHEREAS, the Village has determined that no harm to the public interest will result from vacation of a portion of the conservation easement on Lot 13, and

WHEREAS, vacation of a portion of the conservation easement will permit construction of the house desired by the owner of Lot 13 and provide tax revenue therefrom, without harm to the public.

NOW THEREFORE, Be It Ordained, by the Village President and Board of Trustees of the Village of Orland Park, Cook County, Illinois as follows:

#### SECTION 1

A portion of the heretofore dedicated conservation easement on:

LOT 13 IN CRYSTAL SPRINGS SUBDIVISION, A SUBDIVISION ON PART OF THE SOUTH HALF OF THE EAST HALF OF THE SOUTHWEST
