ABROGATION AGREEMENT

- D. HARRIS is the owner of the real property commonly known as Lot 28 in The Park at Chicago Ridge, Chicago Ridge, Illinois 60415. (See Exhibit "D" for legal description.)
- E. FALCO is the owner of the real property commonly known as Lots 52 and 53 in The Park at Chicago Ridge. Chicago Ridge, Illinois 60415. (See Exhibit "E" for legal description.)
- F. A Declaration of Easement (hereinafter, "Declaration") with respect to the above-referenced lots (collectively "Subject-Property") and dated April 29, 1987, was received April 30, 1987 in the Office of the Recorder of Cook County as Document No. 87229973.

THE WAR

- G. FIRST NATIONAL, KAPASI, STANDARD BANK and HARRIS are the sole beneficiaries of the perpetual access easement(s) created by the Declaration over and upon the West Easement Parcel, as defined in the Declaration.
- H. FIRST NATIONAL and FALCO are the sole beneficiaries of the perpetual access easement(s) created by the Declaration over and upon the East Easement Farcel, as defined in the Declaration.
- I. Having reached an agreement, FIRST NATIONAL, KAPASI, STANDARD BANK, HARRIS and FALCO wish to abrogate, and to release/he released from the benefits and burdens of, the perpetual access easements created by the Declaration (hereinafter, "Easements") over and upon the East and West Easement Farcels.

II. AGREEMENTS

- A. For valuable consideration, the receipt and sufficiency of which is hereby accommedged each to the other, FIRST NATIONAL, KAPASI, STANDARD BANK, HARRIS and FALCO hereby abrogate, abandon, reliquish and forfeit any rights and benefits they, as owners of the Subject-Property, each may have, jointly and/or individually, as a result of the Easements over and upon the East and West Easement Parcels; further, it is agreed that the Subject-Property is hereby released from the burdens and encroachments of the Easements over and upon the East and West Easement Parcels.
- B. It is agreed and acknowledged that this agreement is being executed as a free and voluntary ect of the undersigned and shall be binding upon and inure to the benufit of the respective successors, heirs and/or assigns of FIRST NATIONAL, KAPASI, STANDARD BANK, HARRIS and FALCO.
- This Agreement is executed by First National Bank of Evergreen Park, not personally, but as Trustee under Trust Agreement Dated December 22, 1992 and Known as Trust No. 12848; and it is expressly understood and agreed by the parties hereto, anything herein to the contrary notwithstanding, that ease and all of the covenants, undertakings and agreements herein ere made and intended not as personal covenants, undertakings and agreements of First National Bank of Evorgreen Park for the purpose of binding it personally; rather, this instrument is executed and delivered by First National Bank of Evergreen Park solely in the exercise of the powers conferred upon it as Trustoe under the above-referenced trust, and no personal liability or personal responsibility is assumed by, nor shall at anytime be assorted or enforced against First National Bank of Evergroon Park, its agents or employees, on account hereof, or on any covenants, undertakings or agreements herein or in said Agreement not contained, either expressed or implied, all such personal

liability, if any, being hereby expressly waived and released by the undersigned, and by all persons claiming by, through or under said parties, and by every person now or hereafter claiming any right(s) hereunder.

D. It is further agreed and acknowledged that (i) this Agreement shall be signed in counterparts, (ii) shall be binding as of the date the last party executes the Agreement, and (iii) all such counterparts shall be construed as a single instrument and shall constitute the full and final Agreement.
