Reference is made to the Agreement for the specific terms, covenants, conditions and provisions thereof which are incorporated herein by this reference. Any term not herein defined shall have the meaning set forth in the Agreement.

COVENANTS. Burrower and London covenant and agree as follows:

- 1. PAYMENT OF PRINCIPAL AND FINANCE CHARGES. Barrower shall promptly pay when due in accordance with the terms of the Agreement the principal and Finance Charges on the indebtedness evidenced by the Agreement, together with any late charges, and other charges imposed under the Agreement.
- 2. TAXES AND INSURANCE. Berrower shall pay, at least ten celendar days before delinquency, all taxes, assessments (including condominium or planned unit development assessments, if any), and ground tents affecting the Property.
