



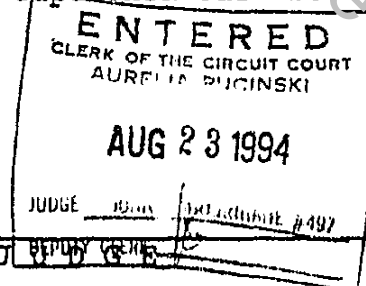
AGREED ORDER OF DISMISSAL
