5. Hazard Insurance. You shall keep the Property insured against loss by fire, hazards included within the term "extended coverage" and any other hazards, including floods or flooding, for which we require insurance. This insurance shall be maintained in the amounts and for the periods that we require. You may choose any insurer subject to our approval, which shall not be unreasonably withheld.

Insurance policies and renewals shall be acceptable to us and shall include a standard mortgagee clause. If we require, you shall promptly give us all receipts of paid premiums and renewal notices. You shall promptly notify the insurer and us of any loss. We may make proof of loss if you do not gromptly do so.

Low Charges If the low secured with Mortory is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from you which exceed permitted limits will be refunded to you. - 13. Notices. Unless otherwise required by law, any notice to you provided for in this Mortgage shall be delivered or mailed by first class mail to the Property Address or any other address you designate by notice to us. Unless otherwise required by law, any notice to us shall be given by first class mail to our address stated above or any other address we designate by notice to you.
- 14. Governing Law; Severability. This Mortgage shall be governed by federal law and, except as preempted by federal law, by the law of the jurisdiction in which the Property is located. In the event that any provision or clause of this Mortgage or the Agreement conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Agreement which can be given effect without the conflicting provision. To this end the provisions of this Mortgage and the Agreement are declared to be severable.
- 15. Transfer of the Property. If all or any part of the Property or any interest in it is sold or transferred (or a s beneficial interest in you is sold or transferred and you are not a natural person) without our prior consent, we may, at our option, require immediate payment in full of all sums secured by this Morrogan. However, this option shall not be exercised by us if exercise is prohibited by federal law as of the dutic of this Mortgage.
- 16. Sale of Apraement; Change of Loan Servicer. The Agreement or a partial interest in the Agreement (together whill this Mortgage) may be sold one or more times without prior notice to you. A sale may result in a change in the artity (known as the "Loan Servicer") that collects monthly payments due under the Agreement and this Mortgage. You shall not do, nor allow anyone else to do, anything affecting the Property that is in vivation of any Environmental Law. The preceding two sentences shall not apply to the presence, use, or stange on the Property of Hazardous Substances in quantities that are generally recognized to be appropriate to normal residential uses and to maintenance of the Property.

You shall promptly give us written notice of any investigation, claim, demand, lawsuit or other action by any governmental or regulatory agency or private perty involving the Property and any Hazardous Substance or Environmental Law of which you have actual trouvledge. If you learn or are notified by any government or regulatory authority, that any removal or of any Hazardous Substance affecting the Property is necessary, you shall promptly take the recessary remedial actions in accordance with Environmental Law.

As used in this Mortgage, "Environmental Law" means federal laws and laws of the jurisdiction where the Property is located that relate to health, safety or environmental protection.

18. Acceleration; Remedies. You will be in default if (1) any payment required by the Agreement is not made when it is due; (2) we discover that you have committed fraud or made a material misrepresentation; or (3) you take any action or fail to take any action that adversely affects our security for the Agreement or any right we have in the Property. If a default occurs, we will give you notice specifying: (a) the default; (b) the action required to cure the default; (c) a date, not less than 30 days from the date the notice is given to you, by which the default must be cured; and (d) that failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding and sale of the Property. The notice shall further inform you of the right to reinstate or redeem after acceleration and the right to assert in the foreclosure proceeding the non-existence of a default or any other defense to acceleration and foreclosure. - 19. Lender in Possession.
