- D. Aetna has endorsed the Notes payable to the Moser Partnership, and the Moser Partnership was the holder of the Notes. Ly that certain Assignment of Note and Liens of even date herewith, Aetna has assigned to the Moser Partnership all of its right, title and interest in the Loan Documents.
- E. The Moser Partnership and the beneficiaries of the Phase II Trust and Phase III Trust entered into an agreement to modify the terms of the Phase II Loan and Phase III Loan pursuant to a Loan Modification Agreement dated as of the 29 in day of July, 1994 and recorded as Document No. _______ in the Recorder's Office.
- F. The Moser Partnership and the Bank have entered into a Credit Agreement dated July 29, 1994 ("Credit Agreement").
- G. Pursuant to the Credit Agreement, the Moser Partnership has endored the Notes (5) payable to the Bank and the Bank is now the holder of the Notes.
- H. Pursuant to the Credit Agreement, the Moser Partnership desires to assign the Mortgages and the Loan Documents to the Bank.
