In consideration of One Dollar (\$1.00) and other valuable consideration, the receipt whereof is hereby acknowledged, Principal National Life Insurance Company ("Principal National"), an Iowa corporation, does hereby sell, transfer, and assign, without recourse, to Principal Mutual Life Insurance Company f/k/a Bankers Life Company ("Principal Mutual"), an Iowa corporation, all of Principal National's right, title and interest in and to that certain Secured Promissory Note ("Note") in the face amount of \$1,180,000.00, executed by LaSalle National Trust, N.A. Successor Trustee to LaSalle National Bank under Trust No. 46332 dated July 11, 1973 together with that certain real estate mortgage, deed of trust or deed to secure debt, as the case may be, (the "Mortgage") encumbering the property more particularly described on Exhibit A which is attached hereto, together with the Note and debt secured thereby and any instrument or document securing the Note, along with any amendment of the Note or Mortgage or any document or instrument securing the Note (all together referred to herein as the "Loan Documents").

The original Mortgage dated June 23, 1992 was initially made by and between LaSalle National Trust, N.A. Successor Trustee to LaSalle National Bank under Trust No. 46332 dated July 11, 1973 and Principal Mutual and was filed for record in the county of Cook, state of Illinois, on July 6, 1992, as Instrument No. 92486207.

The Loan Documents were subsequently assigned by Principal Mutual to Principal National by an Assignment of Note and Mortgage ("Assignment"), said Assignment being recorded in the county of Cook, state of Illinois, on March 9, 1993, as Instrument No. 93174425.

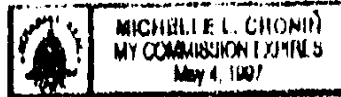
