ORDINANCE NO. 1688

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO
THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

WHEREAS, the corporate authorities of the Village of Glenview, have determined that annexation of certain territory in Cook County, Illinois, hereinafter described, is in the public interest and in the best interests of the Village of Glenview, and will promote the public health, safety and welfare of the Village and its residents; and

WHEREAS, the corporate authorities of the Village of Glenview, a home rule municipality, find that the following described territory is unincorporated territory containing less than 60 acres, and is wholly bounded by the Village of Glenview.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that

Section 1: The facts and statements contained in the preamble to this ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

Section 2: The unincorporated territory, containing less than 60 acres and wholly bounded by the Village of Glenview and is legally described as:

Lots 361, 362, and 363 in Eugenia Unit No. 3 being a subdivision of part of the north west quarter of the south west quarter of Section 12, Township 41 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.

be and the same is hereby annexed to the Village of Glenview, Cook County, Illinois, pursuant to the provisions of Cook County, Illinois, pursuant to the provisions of Section 7-1-13 of the Illinois Municipal Code.

Section 3: The Clerk of the Village of Glenview is hereby authorized and directed to record with the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with an accurate map of the territory annexed, attached hereto and made a part hereof and a document of annexation shall be filed with the County Clerk and the County Election Authority.

Section 4: This ordinance shall take full effect upon its passage and approval according to law.




