Notwitheranding any other provisions hereof, so long as there shall exist to default in the payment of the indebtedness or in the performance of any obligation, covenant or agreement herein or in said Mortgage or other instrument contained, Assignor shall have the right to collect when, but not before, due all rents, issues, and profits from said property and to retain, use and enjoy the same.

Without limiting the generality of the foregoing, this Assignment covers specifically any lease or leases domaining all portions of the following properties for the terms shown:

Concerning each lease hereinabove described, in the event that Assignor is in default under this Assignment, the Mortgage or the Note, Assignor hereby covenants and agrees to and with the Assignee that without the written consent of the Assignee first obtained, Assignor will not:

- 1. Cancel or terminate such lease for any reason whatsoever irrespective of how such right of cancellation or termination is obtained, or parmit the cancellation or termination thereof;
- 2. Reduce the rent provided for in such leasn; modify such lease in any way, either orally or in writing; or grant any concession in connection with such lease, either orally or in writing;
- 3. Consent to any Assignment of the interest of the tenant in the Lease, or to any sub-letting thereof;
- 4. Accept; any rent payable under the lease in advance of the time when the same is payable under the terms thereof; and any of the above acts, if don, without the written consent of the Assignee, shall be null and void.

Any default on the part of the Assignor hereunder shall constitute a default of Assignor under the Mortgage.

In accepting this Assignment the Assignee herein does not assume nor shall it be under any obligation whatever to perform any of the covenants, undertakings or promises on the part of the Lessor to be performed under any lease which may be entered into concerning the said property.

If Assignor shall pay all the ledebtedness when or before due and shall keep, observe and fully perform all the covenants, conditions, stipulations and agreements herein contained, then this Assignment shall be null and void and Assignee will, promptly upon Assignor's demand therefore, release and discharge this Assignment.

This Assignment shall be governed and controlled by the laws of the State of Illinois.
