purposes herein and in said trust agreement set forth.

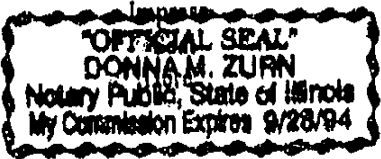

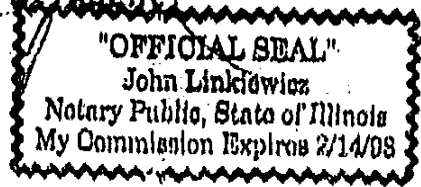

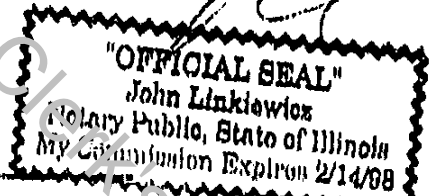
