- 6. Gramors shall pay each item of indebtedness bettern mentioned, both principal and interest, when the according to the terms hersof. At the option of Beneficiary, and without notice to Gramors, all unpaid indebtedness secured by this Trust Dead shall, notwithstanding anything in the Contract or in this Trust Dead to the contrary, become due and payable (a) immediately in the case of default in making payment of any installment on the Contract, or (b) when default shall occur and continue for three days in the performance of any other agreement of the Grantors herein contained, or (c) immediately if all or part of the premises are sold or transferred by the Grantors without Beneficiary's prior written content.

Such receiver shall have the power to collect the errat, issues and profits of said premises during the pendency of such freeclosure unit and, in case of a sale and a deficiency, during the full stantistic, period of redemption, whether there be referringtion or nix, a well as during any further times when Grastors, except for the intervention of such receiver, would be establed to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of add period.
