There is now justly due and owing to claimant \$90,507.84, which is still due and 2. unpaid, plus interest from August 31, 1994.

Claimant now claims a lien on the above-described property and all improvements 3. on it, against the owner and all persons interested, and also claims a lien on my amounts due from the owner to the original contractor, for \$90,907.84, together with interest, according to the statute.
