MORTGAGE, SECURITY AGREEMENT AND FINANCING STATEMENT

This MORTGACE, SECURITY AGREEMENT AND FINANCING STATEMENT is executed as of December 20, 1993 by AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, a national banking association, whose address is 33 North La Salle Street, Chicago, Illinois 60690, not personally, but solely as Trustee under a Trust Agreement dated September 18, 1986 and known as Trust No. 100055-02 (the "Mortgagor") to LASALLE NATIONAL BANK, a national banking association (the "Mortgagee"), whose address is 120 South La Salle Street, Chicago, Illinois 60603.

WITNESSETH:

WHEREAS, the Mortgagor is justly indebted to the Mortgagee in the principal sem of One Million Two Hundred Fifty Thousand and 00/100 Dollars (\$1,250,000.00), as evidenced by that certain Note dated as of December 20, 1993 (together with any and all notes issued in renewal thereof or in substitution or replacement therefor being collectively referred to herein as the "Note"), executed by the Mortgagor and made payable to the order of and delivered to the Mortgagoe in and by which Note the Mortgagor promises to pay the principal sum thereof, together with interest thereon prior to maturity of the occurrence of a Default (as defined herein) at the rate per annum of seven and three-quarters percent (the "Interest Rate") and following maturity or the occurrence of a Default at the Interest Rate plus three percent (the "Default Rate"), and prepayment premium, if any. Each installment shall be paid at such place as the holder of the Note may, from time to time, in writing appoint, and in the absence of such appointment, at the Mortgagee's office set forth above; and

NOW, THEREFORE, in consideration of the obligations and liabilities evidenced by the Note, and to secure the payment of the principal sum of money and the interest in accordance with the terms, provisions and limitations of this Mortgage, and of the Note (the Note, this Mortgage and any and all other documents executed in connection therewith being collectively, are referred to herein as the "Loan Documents"), including any and all excessions, modifications and renewals of the foregoing indebtedness, and the performance of the covenants and agreements herein contained, by the Mortgagor to be performed, and also in consideration of the sum

of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged, the Mortgagor does by these presents GRANT, MORTGAGE, WARRANT and CONVEY unto the Mortgagee, its successors and assigns, the following:

- (a) All that certain described real estate and all of its estate, right, title and interest therein, situate, lying and being in County of Cook, State of Illinois, which is more specifically described on Exhibit "A" attached hereto, which, with the property hereinafter described, is referred to herein as the "Premises";
- (b) All improvements, tenements, easements, fixtures, and approximances thereto belonging, and all rents, issues and profits thereof for so long and during all such times as the Mortgagor may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondarily);
- If and to the extent owned by the Mortgagor, all fixtures, fittings, furnishings, appliances, apparatus, equipment and machinery including, without limitation, all gas and electric fixtures, radiators, heaters, engines and machinery, boilers, ranges, ovens, elevators and motors, bathtubs, sinks, water closets, basins, pipes, faucets and other air-conditioning, plumbing and heating fixtures, mirrors, refrigerating plants, mantles, refrigerators, iceboxes, dishwashers, carpeting, furniture, equipment, cooking apparatus and appurtenances, building material, supplies and equipment now or hereafter delivered to the Premises and intended to be installed therein; all other fixtures and personal property of whatever kind and nature at present contained in or hereafter placed in any building standing on said Premises; such other goods, equipment, chattels and personal property as are usually furnished by landlords in letting other premises of the character of the Premises; and all renewals or replacements thereof or articles in substitution thereof; and all proceeds and profits thereof and all of the estate, right, title and interest of the Mortgagor in and to all property of any nature whatsoever, now or hereafter situated on the Premises or intended to be used in connection with the operation thereof;
- (d) All of the right, title and interest of the Mortgagor in and to any fixtures or personal property subject to a lease agreement, conditional sale agreement, chattel mortgage, or security agreement, and all deposits made thereon or therefor, together with the benefit of any payments now or hereafter made thereon;
- (e) All leases and use agreements of machinery, equipment and other personal property of the Mortgagor in the categories hereinabove set forth, under which the Mortgagor is the lessee of, or entitled to use, such items;

- (f) All rents, income (including income and receipts from the use and occupancy of any hotel rooms), profits, revenues, receipts, royalties, bonuses, rights, accounts, contract rights, general intangibles and bonefits and guarantees under any and all leases, tenancies, licenses or other use agreements or arrangements now existing or hereafter created of the Premises or any part thereof (including any business conducted thereon) with the right to receive and apply the same to indebtedness due the Mortgages and the Mortgages may demand, sue for and recover such payments but shall not be required to do so;
- (g) All judgments, awards of damages and settlements hereafter made as a result of or in lieu of any taking of the Promises of any part thereof or interest therein under the power of eminent domain, or for any damage (whether caused by such taking or otherwise) to the Premises or the improvements thereon or any part thereof or interest therein, including any award for change of grade of streets;
- (h) All proceeds of the conversion, voluntary or involuntary of any of the foregoing into each or liquidated claims;
- (i) Any monies on deposit with the Mortgagee for the payment of real estate taxes or special assessments against the Premises or for the payment of premiums on policies of fire and other hazard insurance covering the collateral described hereunder or the Premises, are all proceeds paid for damage done to the collateral described hereunder or the Premises;
- (j) All substitutions, replacements, additions and proceeds, including insurance and condemnation award proceeds, of any of the foregoing property; it being understood that the enumeration of any specific articles of property shall in no wise exclude or be held to exclude any items of property not specifically mentioned. All of the land, enacte and property hereinabove described, real, personal and allxed, whether affixed or annexed or not (except where otherwise hereinabove specified) and all rights hereby conveyed and moregaged are intended so to be as a unit and are hereby understood, agreed and declared to form a part and parcel of the real estate and to be appropriated to the use of the real estate, and shall be for the purposes of this Mortgage deemed to be real estate and conveyed and mortgaged hereby.

As to any of the property aforesaid which (notwithstanding the aforesaid declaration and agreement) does not so form a part and parcel of the real estate, this Mortgage is hereby deemed to be, as well, a Security Agreement under the Uniform Commercial Code in effect in the jurisdiction in which the Premises are located (hereinafter referred to as the "UCC") for the purpose of creating hereby a security interest in such property, which the Mortgagor hereby grants to the Mortgagee as Secured Party (as said term is defined in the UCC), securing said indebtedness and obligations and

the Mortgagee shall have in addition to its rights and remedies hereunder all rights and remedies of a Secured Party under the UCC. As to above personal property which the UCC classifies as fixtures, this instrument shall constitute a fixture filing and financing statement under the UCC.

The Mortgagor and the beneficiary of the Mortgagor (the "Beneficiary") covenant (i) that the Mortgagor is lawfully seized of the Premises, (ii) that the same are subject only to the liens, encumbrances, conditions, restrictions, easements, and other matters, rights or interests disclosed in Exhibit "B" attached hereto and made a part hereof, and (iii) that the Mortgagor has good right, full power and lawful authority to convey and mortgage the same and that it will warrant and forever defend said Premises and the guist and peaceful possession of the same against the lawful claims of all persons whomsoever.

As used in this Mortgage, the term "indebtedness" shall mean and include the principal sum evidenced by said Note, together with all interest and late charges thereon, any other payments due to the Mortgagee thereunder, and all other sums at any time secured by this Mortgage. Further as used in this Mortgage, the term "Note" shall mean and include try renewals, modifications, extensions, amendments and replacements thereof.

TO HAVE AND TO HOLD the Promises unto the Mortgagee, its successors and assigns, for the purposes and uses herein set forth.

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

Maintenance, Repair and Restoration of Improvements, Payment of Prior Liens, etc.

The Mortgagor shall (a) promptly repair, restore or rebuild any buildings or improvements now or horeafter on the Premises which may become damaged or be destroyed. (b) keep said Premises in good condition and repair, without waste, and free from mechanica' liens or other liens or claims for lien not expressly subordinated to the lies hereof, other than any such items which are being contested in a diligent and good faith warmer by appropriate proceedings; (c) pay when due any indebtedness which may be secured by a lies or charge on the Premises superior to the lion horoof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to the Mortgagee; (d) complete within a reasonable time any building or buildings new or at any time in process of erection upon said Fremises; (e) comply with all requirements of law, municipal ordinances, or restrictions of record with respect to the Premises and the use thereof; (f) make no alterations in said Premises; (g) suffer or permit no change in the general nature of the occupancy of the Preminen, without the Mortgagoe's prior writton consent; (h) initiate or acquiesce in no zoning variation or reclassification, without the Mortgagee's prior written consent; (i) pay each item of indebtedness secured by this Mortgage when due according to the terms hereof or of said Note.

Payment of Taxes

2. The Mortgagor shall pay, before any penalty attaches, all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the Premises when due, and shall, upon written request, furnish to the Mortgagee duplicate receipts therefor.

Tax Deposits

Immediately upon the occurrence of a Default hereinafter defined) which is not cured within any applicable grace period the Mortgagor covenants and agrees to deposit with the Mortgagee at the office of the Mortgagee set forth on the first page of this Mortgage, commencing on the first day of the calendar month following such request by the Mortgagee, and on the first day of each calendar month thereafter until the indebtedness secured by this Mortgage is rully paid, a sum equal to one-twelfth of the last annual taxes and general and/or special assessments (collectively, the "Taxes") for the last ascertainable year on said Premises (unless such Taxes are based upon assessments which exclude the improvements or any part thereof now constructed or to be constructed, in which event the amount of such deposits shall be based upon the Mortgagee's reasonable estimate as to the amount of Taxes to be levied and asserged). Such deposits shall be held without allowance for interest and shall be used for the payment of Taxes on said Premises next due and payable when they become due. If the funds so deposited are insufficient to pay any the Taxes for any year when the same shall become due and payable, the Mortgagor shall, within ten (10) days after receipt of demand therefor, deposit such additional funds as may be necessary to pay the Taxes in full. If the funds so deposited exceed the amount required to pay the Taxes for the year, the excess shall be applied on a subsequent deposit or deposits. Said deposits need not be kept separate and apart from other funds of the Mortgagee.

Anything in this Paragraph 3 to the contrary notwithstanding, if the funds so deposited are insufficient to pay the Taxes or any installment thereof, the Mortgagor will, not later than chirty (30) days prior to the last day on which the same may be paid without penalty or interest, deposit with the Mortgagee the full amount of any such deficiency.

If any Taxes shall be levied, charged, assessed or imposed upon or for the Premises, or any portion thereof, and if such Taxes shall also be a levy, charge, assessment or imposition upon or for any other premises not covered by the lien of this Mortgage, then the computation of any amount to be deposited under this Paragraph 3 shall be based upon the entire amount of such Taxes, and the Mortgagor shall not have the right to apportion the amount of any such taxes or assessments for the purpose of such computation.

Morrgagee's Interest In and Use of Deposits

In the event of a Dofault herounder or the Note secured hereby, the Mortgagee may at its option, without being required to do so, apply any monies at the time of deposit pursuant to Paragraphs 3 and 5 hereof, on any of the Mortgagor's obligations herein or in said Note contained, in such order and manner as the Mortgagee may elect. When the indebtedness secured hereby has been fully paid, any remaining deposits shall be paid to the Mortgagor or to the then owner of the Premises. A security interest within the meaning of the UCC is hereby granted to the Mortgagee in and to any monies on deposit pursuant to Paragraphs 3 and 5 hereof, as additional security for the indebtedness hereunder and shall be applied by the Mortgagee for the purposes made hereunder and shall not be subject to the direction or control of the Mortgagor; provided, nowever, that the Mortgagee shall not be liable for any failure to apply to the payment of taxes, assessments and insurance premiums any amount so deposited unless the Mortgagor, while not in Default hereunder shall have requested the Mortgagee in writing to make application of such funds to the payment of the particular taxes, assessments and insurance premiums for payment of which they deposited, accompanied by the bills for such assessments and insurance premiums. The Mortgagee shall not be liable for any act or omigation taken in good faith or pursuant to the instruction of any party out shall be liable only for its gross negligence or willful misconduct.

Insurance

The Mortgagor shall keep all buildings and improvements now or hereafter situated on the Premises insured against loss or damage by policies of All Risk Replacement Cost Insurance with an Agreed Amount Endorsement and such other appropriate insurance, all in form and substance satisfactory to the Matgagee, including, limitation, business interruption insurance, insurance (if and when the Premises lie within an area designated by an agency of the federal government as a flood risk area) and war risk insurance whenever in the opinion of the Morigagee such protection is necessary and such war risk insurance is obtainable The Mortgagor from an agency of the United States Government. shall also provide liability insurance with such limits for personal injury and death and property damage as the Mortgage may require. All policies of insurance to be furnished hereunder shall be in forms, companies and amounts reasonably satisfactory to the Mortgagee, each insurer to have a Best's rating of A+:XV, with mortgagee clauses attached to all policies in favor of and in form satisfactory to the Mortgagee, including a provision requiring that the coverage evidenced thereby shall not be terminated or materially modified without 10 days' prior written notice to the The Mortgagor shall deliver all policies including additional and renewal policies, to the Mortgagee, and, in the case of insurance about to expire, shall deliver renewal policies not less than ten (10) days prior to their respective dates of expiration.

The Mortgagor shall not take out separate insurance concurrent in form or contributing in the event of loss with that required to be maintained hereunder unless the Mortgagee is included thereon under a standard mortgagee clause acceptable to the Mortgagee. The Mortgagor shall immediately notify the Mortgagee whenever any nuch separate insurance is taken out and shall promptly deliver to the Mortgagee the policy or policies of such insurance.

Upon the occurrence of a Default herounder and tollowing request by the Mortgagee, the Mortgager shall deposit with the Mortgagee, beginning on the first day of the calendar month following such request by the Mortgagee and continuing on the first day of each month thereafter, an amount equal to the premiums that will next become due and payable on such policies divided by the number of rouths to elapse prior to the date when such premiums become delingment. No interest shall be payable on such deposits, and such deposits need not be kept in a separate account.

Adjustment of Lossie With Insurer and Application of Proceeds of Insurance

In case of loss or damage by fire or other casualty, the 6. Mortgagee is authorized (a) to settle and adjust any claim under insurance policies which inverse against such risks, or (b) to allow the Mortgagor to agree with the insurance company or companies on the amount to be paid in regard to such loss. In either case, the Mortgagee is authorized, to collect and issue a receipt for any such insurance money. Such insurance proceeds shall be applied to reimburse the Mortgagor for the cost of rebuilding and restoration, or to reduce the indebtedness secured hereby if such rebuilding or restoration is not economically practical. Irrespective of whether such insurance proceeds are used to reimbarse the Mortgagor for the cost of said robuilding or restoration or not, and irrespective of whether such insurance proceeds are or are not adequate for such purpose, the buildings and improvements shall be so restored or rebuilt so as to be of at least equal value and apparantially the same character as prior to such damage or destruction. If the cost of rebuilding, repairing or restoring the building and improvements can reasonably exceed the sum of \$25,000, then the Morrougue shall approve plans and specifications of such work before each work shall be commenced. In any case, where the insurance proceeds are used for rebuilding and restoration, such proceeds shall be disbursed in the manner and under the conditions that the Mortgagee may require and upon the Mortgagee being furnished with satisfactory evidence of the estimated cost of completion thereof and with architect's certificates, waivers of lien, contractor's and subcontractors' sworn statements and other evidence of cost and payments so that the Mortgagee can verify that the amounts disbursed from time to time are represented by completed and in place work and that said work is free and clear of mechanics' lien claims. If the estimated cost of completion exceeds the amount of the insurance proceeds available, the Mortgagor immediately shall, on written demand of the Mortgagee, deposit with the Mortgagee in cash the amount of such estimated excess cost. No payment made

prior to the final completion of the work shall exceed ninety percent (90%) of the value of the work performed from time to time, and at all times the undisbursed balance of such proceeds remaining in the hands of the disbursing party shall be at least sufficient to pay for the cost of completion of the work free and clear of liens. Any surplus which may remain out of said insurance proceeds after payment of such cost of building or restoration shall, at the option of the Mortgagee, be applied on account of the indebtedness secured hereby or be paid to any party entitled thereto without interest.

Stamp Tax

7. If, by the laws of the United States of America, or of any state having jurisdiction over the Mortgagor, any tax is due or becomes due in respect of the issuance of the Note hereby secured, the Mortgagor covenants and agrees to pay such tax in the manner required by any such law. The Mortgagor further covenants to reimburse the Mortgagee for any sums which the Mortgagee may expend by reason of the imposition of any tax on the issuance of the Note.

Lease of Premises

8. As additional accurity for the payment of the Note secured hereby and for the faithful performance of the terms and conditions contained herein, the Mortgagor, as landlord, has assigned to the Mortgagee all of its right, title and interest as landlord in and to all existing leases and occupancy agreements with respect to the Premises. All future leases of the Premises are subject to the approval of the Mortgagee as to form, content and tenants, except that the Mortgagor may amend any such lease without the prior written consent of the Bank, provided that the rent payments or the term of the Lease are not reduced or no other provision of the Lease is amended which would have a material adverse affect on the Bank or the security for the Note.

The Mortgagor shall not, without the Mortgagee () prior written consent, (i) execute an assignment or pledge of any rents of the Premises and/or any leases of the Premises; (ii) accept any prepayment of any installment of any rents more than thirty (30) days before the due date of such installment; or (iii) make any lease of the Premises.

The Mortgagor, at its sole cost and expense, shall (i) at all times promptly and faithfully abide by, discharge and perform all of the material covenants, conditions and agreements contained in all leases or occupancy agreements of the Prominen, on the part of the landlord thereunder to be kept and performed, following any applicable grace or cure period; (ii) enforce or secure the performance of all of the material covenants, conditions and agreements of such leases on the part of the leases or occupant to be kept and performed; (iii) appear in and defend any action or proceeding arising under, growing out of or in any manner connected with such leases or occupancy agreements or the obligations, duties

or liabilities of landlord or of the lessees thereunder; (iv) furnish the Mortgagee, within twenty (20) days after a request by the Mortgagee to do so, a written statement containing the names of lessees or occupants, terms of all leases or occupancy agreements of the Premises, including the spaces occupied and the rentals payable thereunder; (v) exercise within five (5) days of any demand therefor by the Mortgagee any right to request from the lessee under any lease of the Premises a certificate with respect to the status thereof; and (vi) not permit any leases of the Premises to become subordinate to any lien on the Premises to become subordinate to any lien on the Premises without the prior written consent of the Mortgagee and will include in each lease or occupancy agreement of the Premises a provision whereby the tenant thereunder covenants that it will not subordinate its leasehold interest therein to any lien on the Premises without the prior written consert of the Mortgagee.

Nothing in this Mortgage or in any other document relating to the loan secured hereby shall be construed to obligate the Mortgagee, expressly or by implication, to perform any of the covenants as landlors under any of the leases or occupancy agreements assigned to the Mortgagee or to pay any sum of money or damages therein provided to be paid by the landlord, each and all of which covenants and payments the Mortgagor agrees to perform and Unless waived by the Wortgagee, all leases of space in the Premises shall have subordination provisions, in form and substance reasonably satisfactory to the Mortgagee, subordinating the interest of the tenants under such leases to this Mortgage, and all modifications, consolidations, replacements extensions hereof and shall have attornment and noncancellation clauses in form and substance reasonably satisfactory to the Mortgagee. Until the indebtedness and other sums secured by this Mortgage are paid in full, the Mortgagee reserves the right to require that specific leases be made either superior to or inferior to the lien of this Mortgage.

In the event of the enforcement by the Mortgagee of the remedies provided for by law or by this Mortgage, the lessee or occupant under each lease or occupancy agreement of the Premises shall attorn to any person succeeding to the interest of the Mortgagor as a result of such enforcement and shall recognize such successor in interest as landlord under such lease without change in the terms or other provisions thereof; provided, however, that said successor in interest shall not be bound by any payment of rent or additional rent for more than one month in advance, and shall not be bound by any amendment or modification to any lease made without the consent of the Mortgagee or said successor in interest. Each lessee, upon request by said successor in interest, shall execute and deliver an instrument or instruments confirming such attornment.

The Mortgagee shall be entitled to cure any default of landlord, within any applicable grace or cure period, in any lease of the Premises, and the cost to effect any curing of default

(including reasonable attorneys' foos), together with interest thereon at the Default Rate (as defined in the Note) shall be so additional indebtedness secured hereby and shall be immediately due and payable without notice.

Effect of Extensions of Time

If the payment of said indebtedness or any part thereof is extended or varied or if any part of any security for the payment of the indebtedness is released or additional security is taken, all persons now or at any time hereafter liable therefor, or interested in said Premises, shall be held to assent to such extension, variation, or taking of additional security or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by the Mortgagee, notwithstanding such extension, variation, taking of additional security or release.

Effect of Changes in Laws Regarding Taxation

10. In the event of the enactment after this date of any law of the state in which the Premises are located deducting from the value of the land for the purpose of taxation any lien thereon, or imposing upon the Mortgagee the payment of the whole or any part of the taxes or assessments or charged or lieus herein required to be paid by the Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or the Mortgagee's interest in the Premises or the manner of collection of taxes, so as to affect this Mortgage or the debt secured hereby or the holders thereof, then, and in any event, the Mortgagor, upon demand by the Mortgagee, shall pay such taxes or assessments, or reimburse the Mortgagee therefor; provided, nowever, that if in the opinion of counsel for the Mortgagee (a) it might be unlawful to require the Mortgagor to make such payment or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law, then and in such event, the Mortgagee may elect, by notice in writing given to the Mortgagor, to declare all of the indebtedness secured hereby to be and become due and payable sixty (60) days from the giving of such notice.

Mortgagee's Performance of Defaulted Acts

11. In the event of a Default hereunder, the Mortgagee may, but need not, make any payment or perform any act herein required of the Mortgagor in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or co interest on prior encumbrances, if any, and purchase, discharge, 🛼 compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said Premises or consent to any tax or assessment or cure any default of landlord in any lease of the Premises. All monies paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and

any other monies advanced by the Mortgagee in regard to any stamp tax or any leases of the Premises or to protect the Premises and the lien hereof, shall be so much additional indebtedness secured hereby, and shall become immediately due and payable without notice and with interest thereon at the Default Rate (as defined in the Inaction of the Mortgagee shall never be considered as a waiver of any right accruing to it on account of any Default hereunder.

Mortgagee's Reliance on Tax Bills, Etc.

The Mortgagee in making any payment hereby authorized: (a) relating to taxes and assessments, may do so according to any bill, starement or estimate produced from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tex lien or title or claim thereof; or (b) for the purchase, discharge, compromise or settlement of any other prior lien, may do so without inquiry as to the validity or amount of any claim for lien which may be asserted.

Acceleration of Indebtochers in Case of Default

- 13. The occurrence of my one or more of the following shall, unless cured within any grace and cure period provided in the Note, constitute a default under this Mortgage (a "Default"):
 - (a) default shall be made in the due and punctual payment of the Note secured hereby, either of principal or interest, or any other payment due in accordance with the terms thereof;
 - dofault shall be made in tips due observance or performance of any of the covenants, agreements or conditions contained herein;
 - the due observance or default shall be made in performance of any of the covenants, agreements or conditions contained in the Note or any other Loan Document;
 - default shall be made in the due payment, observance or performance of any of the material covenants and agreements or conditions contained in any other agreements or financing arrangements now existing or hereafter entered into between the Beneficiary and the Mortgagee, or between the Mortgagor and any other party;
 - any of the Mortgagor, the Beneficiary or any guarantor of 🏖 the Note secured hereby (herein a "Guaranter") shall file a partition seeking relief under the Federal Bankmutcy Code (11 petition seeking relief under the Federal Bankruptcy Code (11 U.S.C. 101 et seq.) or any similar law, state or federal, whether now or hereafter existing, or any answer admitting insolvency or inability to pay its or their debts;
 - an order for relief shall be entered in an involuntary case against any of the Mortgagor, the Beneficiary or a

Guarantor, or a trustee or a receiver shall be appointed for any of the Mortgagor, the Beneficiary or a Guarantor, or for all of the property of any of the Mortgagor, the Beneficiary or a Guarantor, or the major part thereof, in any involuntary proceeding, or any court shall have taken jurisdiction of the property of any of the Mortgagor, the Beneficiary or a Guarantor, or the major part thereof, in any voluntary or involuntary proceeding for the reorganization, dissolution, liquidation or winding up of any of the Mortgagor, the Beneficiary or a Guarantor;

- (g) any of the Mortgagor, the Beneficiary or a Guarantor shall make an assignment for the benefit of creditors, or shall admit in writing its inability to pay its debts generally as they become due, or shall consent to the appointment of a receiver or trustee or liquidator of all of its property or the major part thereof;
- (h) any event occurs or condition exists which constitutes a default, following any applicable grace or cure period, under any of the Loan Cocuments; or
- (i) an unpermitted transfer as described in Section 31 of this Mortgage shall corpr.

the occurrence of a Default, the whole of the indebtedness hereby secured shall, at once, at the option of the Mortgagee, become immediately due and payable without notice to the Mortgagor. If, while any insurance proceeds or condemnation awards are being held by the Mortgagee to reimpurse the Mortgagor for the cost of rebuilding or restoration of buildings or improvements on the Premises, as set forth in Paragraph 6 or 21 hereof, the Mortgagee shall be or become entitled to, and shall accelerate the indebtedness secured hereby, then and in such event, the Mortgagee shall be entitled to apply all such insurance proceeds and condemnation awards then held by it in reduction of indebtedness hereby secured (less the amount thereof, if any, which is then currently payable for work completed and in place in connection with such rebuilding or restoration), and one excess held by it over the amount of indebtedness then due hereunder shall be returned to the Mortgagor or any party entitled therete without interest.

Foreclosure: Expense of Litigation

14. When the indebtedness hereby secured, or any part thereof, shall become due, whether by acceleration or otherwise, the Mortgages shall have the right to foreclose the lien hereof, for such indebtedness or part thereof. In any civil action to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the order or judgment for sale all reasonable expenditures and expenses which may be paid or incurred by or on behalf of the Mortgages for attorneys' fees, appraiser's fees, outlays for documentary and expert evidence, stenographers' charges, publication costs, and costs (which may be estimated as to

items to be expended after entry of the order or judgment) of procuring all such abstracts of title, title searches and examinations, title insurance policies, Torrens certificates, and similar data and assurances with respect to title as the Mortgagee may deem reasonably necessary either to prosecute such civil actions or to evidence to bidders at any sale which may be had pursuant to such order or judgment the true condition of the title to or the value of the Premises. All expenditures and expenses of the nature in this paragraph mentioned, and such expenses and fees as may be incurred in the protection of said Premises and maintenance of the lien of this Mortgage including the fees of any attorney employed by the Mortgagee in any litigation or proceeding affecting this Mortgage, said Note or said Premises, including probate, bankruptcy and appellate proceedings, or in preparations for the commencement or defense of any proceeding or threatened civil actions or proceeding shall be immediately due and payable by the Mortgagor, with interest thereon at the Default Rate (as defined in the Note), and shall be secured by this Mortgage.

Application of Proceeds of Foreclosure Sale

15. The proceeds of any foreclosure sale of the Premises shall be distributed and applied in the following order of priority: first, on account of all costs and expenses incident to the foreclosure proceedings including all such items as are mentioned in the preceding paragraph hereof; second, all other items which may under the terms hereof constitute secured indebtedness additional to that evidenced by the Note, with interest thereon as herein provided; third, all principal and interest remaining unpaid on the Note, and fourth, any surplus to the Mortgagor, its successors or assigns, as their rights may appear.

Appointment of Receiver

16. Upon, or at any time after the filing of a complaint to foreclose this Mortgage, the court in which such conplaint is filed may appoint a receiver of said Premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of the Mortgagor at the time of application for such receiver and without regard to the tren value of the Premises or whether the same shall be then occupied as a homestead or not and the Mortgagee hereunder or any holder of the Note may be appointed as such receiver. Such receiver shall have power to collect the rents, issues and profits of said Premises, during the pendency of such foreclosure suit and during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when the Mortgagor, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the Premises during the whole of said period. Mortgagee's Right of Possession in Case of Default

In the event of a Default, whether before or after the whole principal sum secured hereby is declared to be immediately due, or whether before or after the institution of legal proceedings to foreclose the lien hereoff or before or after nate thereunder, forthwith, upon domand of the Mortgages, the Mortgager shall surrender to the Mortgagee and the Mortgagee shall be ontitled to take actual possession of the Promises or any part thereof personally, or by its agent or attorneys, as for condition In such event the Mortgagee in its discretion may, in accordance with law, onter upon and take and maintain possession of all or any part of said Promises, together with all documents, books, records, papers and accounts of the Moregagor or then owner of the Premises relating thereto, and may exclude the Mortgagor, its agents or servants, wholly therefrom and may as attorney in fact or agent of the Moragagor, or in its own name as the Moragagee and under the powers here granted, hold, operate, manage and control the Premises and conduct the business, if any, thereof, either personally or by its agents, and with full power to use such measures, legal or equitable, as in its discretion or in the discretion of its successors or estigns may be deemed proper or necessary to enforce the payment or security of the avails, rents, issues, and profits of the Premises, including actions for the recovery of rent, actions in forcible detainer and actions in distress for rent, and with full power: (a) to cancel or terminate any lease or sublease for any cause or on any ground which would entitle the Mortgagor to cancel the same; (b) to elect to disaffirm any lease or sublease which is then subordinate to the lien hereof; (c) to extend or modify any then existing leases and to make new leases, which extensions, modifications and new leases may provide for terms to expire, or for options to lessees to extend or renew terms to expire, beyond the maturity date of the indeptedness hereunder and beyond the date of the issuance of a deed or deeds to a purchaser or purchasers at a foreclosure sale, it being understood and agreed that any such leases, and the options or other such provisions to be contained therein, shall be binding upon the Mortgagor and all persons whose interests in the Premises are subject to the lien hereof and upon the purchaser or purchasers at any foreclosure sale, notwithstanding any redemption from a foreclosure of this Mortgage, discharge of the mortgage indebtedness, satisfaction of any foreclosure decree, or issuance of any certificate of sale or deed to any purchaser; (d) to make necessary proper repairs, decorating, Or. replacements, alterations, additions, betterments and improvements to the Premises as to it may seem judicious; (e) to insure and reinsure the same and all risks incidental to the Mortgagee's possession, operation and management thereof; and (f) to receive all of such avails, rents, issues and profits; hereby granting full

power and authority to exercise each and every of the rights, privileges and powers herein granted at any and all times hereafter, without notice to the Mortgagor.

The Mortgagee shall not be obligated to perform or discharge, nor does it hereby undertake to perform or discharge, any obligation, duty or liability under any leases. The Mortgagor shall and does hereby agree to indemnify and hold the Mortgagee harmless of and from any and all liability, loss or damage which the Mortgagee may or might incur under said leases or under or by reason of the assignment thereof and of and from any and all claims and demands whatsoever which may be asserted against it by reason of any anleged obligations or undertakings on its part to perform or discharge any of the terms, covenants or agreements contained in said leases. excepting any of the foregoing which result from the gross negligence or willful misconduct of the Mortgagee. the Mortgagee Dour any such liability, loss or damage, under said leases or under cr by reason of the assignment thereof, or in the defense of any claims or demands, the amount thereof, including costs, expenses and resonable attorneys' fees, shall be secured hereby, and the Mortgagor shall reimburse the Mortgagee therefor immediately upon demand.

Application of Income Received by Mortgagee

- 18. The Mortgages, in the exercise of the rights and powers conferred herein and upon the occurrence of a Default, shall have full power to use and apply the avaira, rents, guest room receipts and income, issues and profits of the cromises to the payment of or on account of the following, in such older as the Mortgages may determine:
 - (a) to the payment of the operating expenses of the Premises, including cost of management and leasing thereof (which shall include appropriate compensation to the Management of agent or agents, if management be delegated to an agent or agents, and shall also include lease commissions and other compensation and expenses of seeking and procuring the ante and entering into leases), established claims for damages, if any, and premiums on insurance hereinabove authorized;
 - (b) to the payment of taxes and special assessments now due or which may horeafter become due on the Promisen; and, if this is a leasehold mortgage, of all rents due or which may become hereafter due under the underlying lease;
 - (c) to the payment of all ropairs, decorating, renewals, replacements, alterations, additions, betterments, and improvements of the Fremises and of placing the Premises in such condition as will, in the reasonable judgment of the Mortgages, make it readily rentable and otherwise in a condition which is comparable to the condition of the Premises preceding the occurrence of the Default;

(d) to the payment of any indebtedness secured hereby or any deficiency which may result from any foreclosure sale.

Rights Cumulative

19. No right, power or remedy herein conferred upon or reserved to the Mortgagee is intended to be exclusive of any other right, power or remedy, and each right, power and remedy herein conferred upon the Mortgagee is cumulative and in addition to every other right, power or remedy, express or implied, given now or hereafter existing, at law or in equity, and each and every right, power and remedy herein set forth or otherwise so existing may be exercised from time to time as often and in such order as may be deemed expedient by the Mortgagee, and the exercise or the beginning of the exercise of one right, power or remedy shall not be a waiver of the right to exercise at the same time or thereafter any other right, power or remedy, and no delay or omission of the Mortgagee in the exercise of any right, power or remedy accruing hereunder or arising otherwise shall impair any such right, power or remedy, or be construed to be a waiver of any default or acquiescence therein.

Mortgagee's Right of Inspection

20. The Mortgagee, upon reasonable advance notice to the Beneficiary, shall have the right to inspect the Premises at all reasonable times and access thereto shall be permitted for that purpose.

Condemnation

21. The Mortgagor hereby assigns, transfers and sets over unto the Mortgagee the entire proceeds of any award or any claim for damages for any of the Premises taken or damaged under the power of eminent domain or by condemnation, up to an amount equal to the then outstanding principal amount of the indebtedness hereby secured, plus all accrued and unpaid interest thereon, and prepayment premium, if any. At the option of the Mortgagee, such condemnation proceeds shall be applied either to reduce the indebtedness secured hereby or to reimburse the Mortgago: for the cost of rebuilding and restoration. Irrespective of whether such proceeds are made available for restoration or rebuilding, and irrespective of whether such proceeds are adequate for such purpose, the buildings and improvements shall be restored or rebuilt in accordance with plans and specifications to be submitted to and approved by the Mortgagee. In the event said proceeds are used for rebuilding or restoration, the proceeds of the award shall be disbursed in the manner and under the conditions that the Mortgagee may require and paid out in the same manner as provided in Paragraph 6 hereof for the payment of insurance proceeds toward the cost of rebuilding or restoration. In such event, if the estimated cost to complete rebuilding or restoration exceeds the proceeds of the condemnations awards, the Mortgagor immediately shall, on written demand of the Mortgagee, deposit with the Mortgagee in cash the amount of such excess cost. Any surplus

The Mortgagor agrees to indemnify and hold harmless the Mortgagee, its affiliates, agents, officers and employees from and against any and all losses, liabilities, suits, obligations, fines, damages, judgments, penalties, claims, charges, costs ara expenses (including reasonable attorneys' fees and disbursements) unich may be imposed on, incurred or paid by or asserted against the Mortgagee by reason or on account of, or in connection with, (i) any willful misconduct of the Mortgagor or any event of Default hereunder or under the other Loan Documents given at any time to secure the payment of the Note secured hereby, (ii) the Mortgagee's good faith and commercially reasonable exercise of any of its 🖒 rights and remedies, or the performance of any of its duties, hereunder or under the other Loan Documents to which the Mortgagor is a party, (iii) the construction, reconstruction or alteration of the Premises, (iv) any negligence of the Mortgagor, or any negligence or willful misconduct of any lessee of the Premises, or any of their respective agents, contractors, subcontractors, servants, employees, licensees or invitees or (v) any accident, injury, death or damage to any person or property occurring in, on or about the Premises or any street, drive, sidewalk, curb or

passageway adjacent therato. Any amount payable to the Mortgagee under this Paragraph shall be due and payable within ten (10) days after demand therefor and receipt by the Mortgagor of a statement from the Mortgagee setting forth in reasonable detail the amount claimed and the basis therefor, and such amounts shall bear interest at the Default Rate (as defined in the Nove) from and after the date such amounts are paid by the Mortgagee until paid in full by the Mortgagor.

The Mortgagor's obligations under this Paragraph shall not be affected by the absence or unavailability of insurance covering the same or by the failure or refusal by any insurance carrier to perform any obligation on its part under any such policy of covering insurance. If any claim, action or proceeding is made or brought against the Mortgagor and/or the Mortgagee which is subject to the indexpity set forth in this Paragraph, the Mortgagor shall resist or deland against the same, if necessary in the name of the Mortgagee, by accorneys for the Mortgagor's insurance carrier (if the same is covered by Insurance) or otherwise by attorneys approved by the workgagee. Notwithstanding the foregoing, the Mortgagee in its resonable discretion, may engage its own attorneys to resist or defend, or assist therein, and the Mortgagor shall pay, or, on demaid, shall reimburse the Mortgagee for the payment of, the reasonable fees and disbursements of said attorneys.

Prohibition on Sale or Financing

31. Except for any sale, corveyance, assignment or other transfer, directly or indirectly, of the beneficial interest of the land trust holding title to the Premises or any portion thereof, to any trust of which the Beneficiary, or his spouse or children, are the trustee or beneficiary, any sale, conveyance, assignment, pledge, hypothecation, mortgage, encumbrance, lease (other than for actual occupancy as consented to by the Mortgagee as provided herein) or other transfer of title to, or any interest therein, directly or indirectly, including, without limitation, the beneficial interest of the Beneficiary or any portion thereof, or of any entity or any person owning, directly or indirectly, any interest therein (whether voluntary or by operation of law, without the Mortgagee's prior written consent shall be a Default hereunder.

It is understood and agreed that the indebtedness secured hereby was created solely due to the financial sophistication, creditworthiness, background and business sophistication of the Beneficiary, and the Mortgagee continues to rely upon same as the \clubsuit means of maintaining the value of the Premises. It is further understood and agreed that any junior financing placed upon the Premises or the improvements located thereon, or upon the interests of the Mortgagor may divert funds which would otherwise be used to pay the indebtedness secured hereby, and could result acceleration and/or foreclosure by any such junior lienor. such action would force the Mortgagee to take measures, and incur expenses, to protect its security, and would detract from the value of the Premises mortgaged hereby, and impair the rights of the

Future Advances

33. This Mortgage and the indebtedness arising hereunder shall be governed by, and construct in accordance with, the internal laws of the State of Illinois applicable to contracts made and performed in such State and any applicable laws of the United States of America.

Miscallanoous

34. This Mortgage and all provisions beroof, shall extend to and be binding upon the Mortgagor and its successors, grantees and assigns, any subsequent owner or owners of the Premiser, and all persons claiming under or through the Mortgagor, including but not limited to, the Beneficiary, and the word "Mortgagor" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the Note or this Mortgage. The word "Mortgagee" when used herein shall include the successors and assigns of the Mortgagee named herein, and the holder or holders, from time to time, of the Note secured hereby.

In the event one or more of the provisions contained in this Mortgage or the Note secured hereby or in any other security documents given to secure the payment of the Note secured hereby shall for any reason be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall, at the option of the Mortgagee, not affect any other provision of this Mortgage, and this Mortgage shall be

construed as if such invalid, illegal or unenforceable provision had never been contained herein or therein.

No personal liability or personal responsibility is to assumed by or shall at any time by asserted or enforceable actinst the Trustee on account of any warranty, indemnity, representation, c covenant, undertaking or agreement of the Trustee in this Mortgage, all such liability being expressly waived by the Mortgagee and by 🕼 every person now or hereafter claiming any right or security N hereunder; and the owner of any indebtedness or cause of action for breach of any warranty, indemnity, representation, covenant, undertaking or agreement accruing hereunder shall look solely to the Trust estate or the Premises conveyed for the payment thereof, by the enforcement of the lien hereby created, in the manner herein and in the Note provided or by action to enforce the personal liability of any guarantor.
