

ARTICLE THREE

The purpose or purposes for which the corporation is organized are:

- To engage in and carry on the business of issuing, as agent for a title insurance company or companies, policies of title insurance and to perform all acts and do all things as are incidental thereto or as are necessary or desirable to accomplish such purpose, including but not limited to: the origination of applications for title insurance, the searching of and the examination of titles to real estate, the preparation and issuance of binders and reports of title, the providing of retainestate transaction closing services including acting an escrow agent in connection therewith, the receiving of and issuance of funds in connection therewith, the issuance, as agents, of title insurance policies.
- 2. To acquire, own, use, convey, lease, and otherwise dispose of and deal in real or personal property or any interest therein.
- 3. In general, to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
