- The Note is hereby modified as follows: 1.
 - (a) The Loan Amount under the Note is increased to \$38,000.00.
 - (b) The Loan Fee under the Note is increased to \$1,140.00.
 - (c) Section 6(b) is amended to provide that each of the Monthly Payments shall be \$684.70, and that the first such Monthly Payment shall be due on November 1, 1993. The Maturity Date shall not change.
