The Trustee or Beneficiary benefit secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriant public office without inquiry into the accutacy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfenure, tax from or rife or claim thereof
