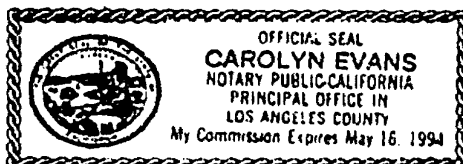

Exhibit A

That portion of a tract of land being part of the North 160 feet of the South 260 feet of the North 581.5 feet of the Southwest Quarter of Section 25, Township 37 North, Range 12 East of the Third Principal Meridian, lying East of the West 458.52 feet thereof and southwesterly of the southwesterly right of way line of the 123rd to 127th Street County Highway Dedication recorded September 22, 1924 as Document Number 8599656, in Cook County, Illinois; and further described as follows:

Beginning at the intersection of the south line of said North 160 feet with the southwesterly right of way line of said County Highway Dedication, being also a point on a 960.95 foot radius curve, the center of circle of said curve bears South 55 degrees 40 minutes 42 seconds West (assumed bearing) from said point; thence northwesterly along said southwesterly right of way line and said curve 204.31 feet through a central angle of 12 degrees 10 minutes 55 seconds to the north line of said North 160 feet; thence South 87 degrees 54 minutes 18 seconds West along said north line 16.90 feet to a point on a 948.95 foot radius curve, the center of circle of said curve bears South 42 degrees 46 minutes 56 seconds West from said point; thence southeasterly along said curve 206.01 feet through a central angle of 12 degrees 26 minutes 18 seconds to the south line of said North 160 feet; thence North 87 degrees 54 minutes 18 seconds East along said south line 14.22 feet to the point of beginning.
