The Director of the Office of Thrift Supervision issued Order number(s) 90-351 dated February 15, 1990, placing Great American Federal Savings and Loan Association, Oak Park, IL in conservatorship and appointing Resolution Trust Corporation as Conservator for Great American Federal Savings and Loan Association.

The Director of the Office of Thrift Supervision issued Order number(s) 90-944 dated May 25, 1990, placing Great American Federal Savings and Loan Association in receivership and appointing the Resolution Trust Corporation as Receiver of Great American Federal Savings and Loan Association pursuant to subdivision (F) of Section 5(d) of the Home Owners' Loan Act, as amended.

The Director of the Office of Thrift Supervision, by Order number(s) 90-945 and 90-946 dated May 25, 1990, incorporated a new federal savings association, Great American Savings and Loan Association, F.A., and issued its charter appointing the Resolution Trust Corporation as Conservator for Great American Savings and Loan Association, F.A., to have "all the powers of a conservator or receiver, as appropriate, granted under the Federal Deposit Insurance Act."

Certain assets of Great American Federal Savings and Loan Association, FRA, Chicago Savings and Loan Association, including the asset which is the subject of this document, have been transferred from Great American Federal Savings and Loan Association to Great American Savings and Loan Association, F.A., and, for the purposes of confirming said transfer, Great American Federal Savings and Loan Association does hereby grant, sell, assign, transfer, set over and convey to Great American Savings and Loan Association, F.A., its successors and assigns, without recourse or warranty, any interest Great American Federal Savings and Loan Association may have in the security document which is the subject of this document, together with the note, debt, and claim secured by such security document and the covenants contained in such security document.
