

EXHIBIT A TO FINANCING STATEMENT

- (1) all furniture, furnishings and equipment furnished by Debtor to tenents of the Real Estate or Improvements:
- (ii) all.[ui]ding materials and equipment located upon the Real Estate and intended to be incorporated in the improvements now or hereafter to be constructed thereon, whether or not yet incorporated in such improvements;
