
That on August 6, 1993, said contractor made a subcontract with the claimant to furnish lumber, millwork, hardware and miscellaneous building materials for and in said improvement, and that on October 28, 1993, the claimant completed thereunder all required to be done under the aforementioned agreement by the delivery of said materials to the value of SIX THOUSAND THIRTY-EIGHT DOLLARS AND 71/100 (\$6,038.71).

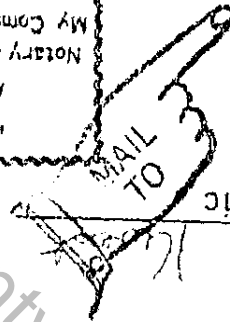
