AND WHEREAS said MORTGAGE securing said Principal Note is valid and subsisting lien of the premises described in said MORTGAGE for the principal sum of FOUR HUNDRED EIGHTY THOUSAND AND NO/100 (\$480,000.00)

AND WHEREAS, the outstanding principal sum of indebtedness of the party of the second part to the party of the first part under the Note, as of the date ingreof is FOUR HUNDRED SEVENTY FOUR THOUSAND, TWO HUNDRED TWENT! FWO AND 84/100 DOLLARS (\$474,222.84) such sum is evidenced by the Note and Mortgage.
