(Legal Description)

PARCEL 1:

Lot 6 in Plotke and Grosby's Resubdivision of the westerly 278 feet of Block 2 in Baird and Warner's Subdivision of Block 12 of Hundley's Subdivision of Lots 3 to 21 inclusive and 33 to 37 inclusive in Pine Grove Subdivision of fractional Section 21, Township 40 North, Range 14, East of the Third Principal Meridian, together with vacated alley in said block and tract of land lying east of and adjoining said Block 12 and westerly of the westerly line of North Shore Drive (except street previously dedicated) in Cook County, Illinois.

PARCEL 2:
