JUDGMENT ORDER IN A CIVIL CASE

This matter having come before the Court on Plaintiff's Motion for Entry of Judgment in a Sum Certain Based on Previous Grant of Summary Judgment, and this Court having granted Summary Judgment in favor of Plaintiff and against Defendants by Order dated December 9, 1993, and this Court being fully advised in the premises;

IT IS HEREBY ORDERED that judgment is entered in favor of Plaintiff, Gerald M. Sullivan, not individually but as a Trustee of Plumbers' Pension Fund, Local 130, U.A.; Plumbers' Welfare Fund, Local 130, U.A.; The Trust Fund for Apprentice and Journeymen Education and Training, Local 130, U.A.; and Chicago Journeymen Plumbers' Local Union 130, U.A., Group Legal Services Plan Fund; and not individually but as Business Manager of Chicago Journeymen Plumbers' Local Union 130, U.A., and against Defendant, Lawrence E. Murrin Plumbing, Inc., an Illinois corporation, in the total amount of \$45,087.35, as itemized below:

- a. In the amount of \$4,375.56 on Count I of the Complaint;
- b. In the amount of \$4,292.25 on Count III of the Complaint;

- c. In the amount of \$29,528.99 on Count IV of the Complaint;
- d. Plus the amount of \$6,690.55 for Plaintiff's attorneys' fees and costs, which represents \$2,296.85 on each Count I, III, and IV of the Complaint;

IT IS FURTHER ORDERED that judgment is entered in favor of Plaintiff, Gerald M. Sullivan, not individually but as a Trustee of Plumbers' Pension Fund, Local 130, U.A.; Plumbers' Welfare Fund, Local 130, U.A.; The Trust Fund for Apprentice and Journeymen Education and Training, Local 130, U.A.; and Chicago Journeymen Plumbers' Local Union 130, U.A., Group Legal Services Plan Fund; and not individually but as Business Manager of Chicago Journeymen Plumbers' Local Union 130, U.A., and against Defendant, Lawrence E. Murrin, individually, in the total amount of \$7,064.10, as itemized below:

- a. In the amount of \$5,167.25 on Count II of the Complaint;
- b. Plus the amount of \$2,296.85 for Plaintiff's attorneys' fees and costs on Count II of the Complaint;

IT IS FURTHER ORDERED that this is a final and appealable Order, and that there is no just reason for delay in enforcement or appeal.
