ADDENDUM: Resolution Trust Corporation Authority

Resolution Trust Corporation was appointed Receiver of City Federal Savings Bank (formerly known as City Federal Savings and Loan Association) by order of the Office of Thrift Supervision ("OTS"), Order No. 89-460 dated December 7, 1989. The RTC, as Receiver for City Federal Savings Bank, immediately organized City Savings Bank, F.S.B., a federally chartered savings association, and authorized to take over such assets and liabilities of the City Federal Savings Bank as the RTC determined to be appropriate. RTC was appointed as Conservator for City Savings Bank, F.S.B. by OTS Order No. 89-462 dated December 7, 1989 pursuant to which RTC succeeded to all rights, titles, powers and privileges of City Savings Bank, F.S.B. On December 8, 1989, the RTC as Receiver for City Federal Savings Bank entered into a Purchase and Assumption Agreement with RTC as Conservator for City Savings Bank, F.S.B. pursuant to which the above referenced mortgage was transferred to City Savings Bank, F.S.B. The RTC was appointed as Receiver for City Savings Bank, F.S.B. by OTS Order No. 90-1753 dated September 21, 1990, pursuant to which RTC succeeded to all rights, titles, powers and privileges of City Savings Bank, F.S.B. The RTC, as Receiver for City Savings Bank, F.S.B., immediately organized City Savings, F.S.B. and caused it to be chartered as a federal savings association. The OTS, by Order No. 90-1766, dated September 21, 1990, appointed RTC as Conservator for City Savings, F.S.B., pursuant to which RTC succeeded to all rights, titles, powers and privileges of City Savings, F.S.B. On September 21, 1990, the RTC as Receiver for City Savings Bank, F.S.B. entered into a Purchase and Assumption Agreement with RTC as Conservator for City Savings, F.S.B., pursuant to which the above referenced mortgage was transferred to City Savings, F.S.B. The OTS, by Order No. 91-17 dated January 11, 1991, appointed RTC as Receiver for City Savings, F.S.B., pursuant to which RTC succeeded to all rights, titles, powers and privileges of City Savings, F.S.B. Together with any and all notes or obligations therein described or referenced to, the debt respectively secured thereby and all rights accrued or to accrue under said mortgage and notes and all sums of money due or to become due thereon, with interest thereon, and attorneys fees and all other charges.
