Resolution Trust Corporation was appointed Receiver of City Federal Savings Bank (formerly known as City Federal Savings and Loan Association) by order of the Office of Thrift Supervision ("OTS"). Order No. 89-460 dated December 7, 1989. The RTC, as Receiver for City Federal Savings Bank, immediately organized City Savings Bank, E.S.B., a federally chartered savings association, and authorized to take over such assets and liabilities of the City Federal Savings Bank as the RTC determined to be appropriate. RTC was appointed as Conservator for City Savings Bank, E.S.B. by OTS Order No. 89-462 dated December 7, 1989 pursuant to which RTC succeeded to all right, powers and privileges of City Savings Bank, E.S.B.
