

ADDENDUM: Resolution Trust Corporation Authority

Resolution Trust Corporation was appointed Receiver of City Federal Savings Bank (fermerly known as City Federal Savings and Loan Association) by order of the Office of Thrift Supervision (*O15"), Order No. 89-460 dated December 7, 1989. The RTC, as Receiver for City Federal Savings Bank, immediately organized City Savings Bank, 1.5.5. a federally chartered savings association, and authorized to take over such assets and biabilities of the City Federal Savings Bank as the RTC determined to be appropriate. RTC was appointed as Conservator for City Savings Bank, 1.5.8. by OTS Order No. 89-462 dated December 7, 1989 pursuant to which RTC as Receiver for City Federal Savings Bank entered into a Purchase and Assumption Agreement with RTC as Conservator for City Savings Bank, F.5.8. pursuant to which the above referenced mortgage was transferred to City Savings Bank, F.5.8. The RTC was appointed as Receiver for City Savings Bank, F.5.8. by OTS Order No. 90-37/3 dated September 21, 1990 pursuant to which RTC succeeded to all rights, titles, powers and privileges of City Savings Bank, F.5.8. minimediately organized City Savings, F.5.8. and caused it to be chartered as a federal savings association. The OTS, by Order No. 90-17/3 dated September 21, 1990, appointed RTC as Conservator for City Savings, F.5.8. pursuant to which RTC succeeded to chartered september 21, 1990, the RTC as Receiver for City Savings, F.5.8.
