MODIFICATION AGREEMENT

This Modification Agreement, dated this 15th day of October, 1993, is by and between NBD Bank, successor by merger to Countryside Bank, a State Banking Association, whose address is 55 E. Euclid, Mtm Brosnect. IL 60056 (hereinafter referred to as "Mortgagee"), NBD Trust Company To Illinois, successor Trustee to First National Bank of Mount Prospect, not personally but as Trustee under Trust Agreement dated 1.1/6/75 and known as Trust #1/T-556 (hereinafter referred to as the "Mortgagor", each such reference to Mortgagor herein being to such trustee solely in its capacity is trustee and not personally or individually), and L. Charles Druhot and Edwina Druhot (hereinafter collectively referred to as "Borrowers").

Whereas, One or more of the parties hereto are signatories of the following documents (hereinafter collectively referred to as "Loan Documents").

- (1) Installment Note (hereinafter referred to as the "Note) dated January 3, 1984 in the principal amount of \$335,000.00;
- Mortgage dated Jamery 3, 1984, executed by the Trustee in favor of Lender given as security for the Note, recorded on County as Document No. January 11, 1984 in Cook referred to as "Mortgage"), pertaining (hereinafter following described premise:

- (4) Collateral Assignment of Beneficial Interest for Collateral Security dated January 3, 1984, assigning 100% of the beneficial interest in and to NBD Trust Company of Illineis, successor trustee to First National Bank of Mount Prospect, as Trustee under Trust #LT-556 from Guaranters to Mortgagee, given as additional security for the Note.
- (5) Assignment of Rights under an Installment Agreement for Deed dated January 3, 1984, executed by the Borrower in favor of the Lender;
- (6) Guaranty of Payment dated January 3, 1984, executed by the Borrowers in favor of Lender;
- (7) Excension Agreement dated July 15, 1992, executed by the Borrowers in favor of Lender;
- (8) Extension Agreement dated January 15, 1993, executed by the Borrowers in favor of Lender;

Whereas, the Parties to this Agreement desire to modify the terms of the Loan Documents to provided for a new final maturity and new payment amount, as specifically described hereinbelow; and

Whereas, the Parties to this agreement desire to reconfirm all other terms set forth in the Loan Documents & in any and all other documents executed in connection with the herein referenced loan.

Now Therefore, in consideration of Ten and 00/100th Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. The Loan Documents are hereby amended to provide that the entire indebtedness evidenced by the Loan Documents as amended, if not sooner paid, is due and payable on the 15th day of June, 1994.
- 2. The Loan Documents are heraby further amended to provide that the payments of \$2,913.23 are changed to \$3,424.53 beginning December 15, 1993.
- 3. Except as herein provided, the loan documents shall remain in full force and effect, specifically, payments shall continue to be made on the 15th day of each month as provided in the loan documents.

Any and all personal liability of NBD Trust Company of Illinois hereunder is hereby expressly waived by the parties and their respective heirs, successors and assigns.
