THIS BALLOON RIDER is made this 2.8 tin day of January, 1994, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure the Borrower's Note to hanket Street Mortgage Corporation (the "Lender") of the same date and covering the property described in the Security Instrument and located at:

The interest rate stated on the Note is called the "Note Rate." The date of the Note is called the "Note Date." I understand the Lender may transfer the Note, Security Instrument and this Rider. The Lender or anyone who takes the Note, the Security Instrument and this Rider by transfer and who is entitled to receive payments under the Note is called the "Note Holder."

ADDITIONAL COVENANTS. In addition to the covenants and agreements in the Security Instrument, Borrower and Lorder further covenant and agree as follows (despite anything to the contrary contained in the Security Instrument or the Note):

1. CONDITIONAL AIGHT TO REFINANCE

At the maturity dath of the Note and Security Instrument (the "Maturity Date"). I will be able obtain a new loan ("New Loan") with a new Maturity Date of Feerwary 1, 2024, and with an interest rate equal to the "New Note Rate" determined in accordar ce with Section 3 below if all the conditions provided in Sections 2 and 5 below are met (the "Conditional Refinancing Ciption"). If those conditions are not met, I understand that the Note Holder is under no obligation to refinance or modify the Note, in to extend the Maturity Date, and that I will have to repay the Note from my own resources or find a lender willing to lend methe money to repay the Note.

2. CONDITIONS TO OPTION

If I want to exercise the Conditional Pelinancing Option at maturity, certain conditions must be met as of the Maturity Date. These conditions are: (1) I must still are the owner and occupant of the property subject to the Security Instrument (the "Property"); (2) I must be current in my monthly payments and cannot have been more than 30 days late on any of the 12 scheduled monthly payments immediately priceding the Maturity Date; (3) no lien against the Property (except for taxes and special assessments not yet due and payable) other than that of the Security Instrument may exist: (4) the New Note Rate cannot be more than 5 percentage points above the Note Rate; and (5) I must make a written request to the Note Holder as provided in Section 5 below.
