THIS FIRST AMENDMENT TO THE WASHINGTON TERRACE TOWNHOMES DECLARATION OF PARTY WALL RIGHTS, COVENANTS, RESTRICTIONS AND EASEMENTS (hereinafter referred to as the "Declaration") is made and entered into on the date hereinafter set forth by AMERICAN NATIONAL BANK AND TRUST COMPANY, a national banking association, not personally, but solely as Trustee under Trust No. 108658-06 (hereinafter referred to as the "Declarant").

WHEREAS, the Declaration was recorded on March 11, 1991, as Document 91107744 in the Office of the Recorder of Deeds of Cook County, Illinois, and has not previously been amended;

WHEREAS, the Declarant has reserved to itself, in Section 12.01 of the Declaration to amend Exhibit A as referred to in Section 1.03 of the Declaration and Exhibit C as referred to in Section 1.19 of the Declaration to annex the Property described in Exhibit A; all or any portion of the Adjoining Parcel described in Exhibit C;

WHEREAS, the Declarant desires to annex Lot 7 as described in Schedule C to the Property by adding said Lot 7 to the legal description set forth on Exhibit A:

NOW THEREFORE, the Declaration is hereby amended as follows:

1. Exhibit A of the Diclaration is amended in the following manner and to the following excent:

Adding Lot 7 thereto so that the Legal Description on Exhibit A to the Washington Terrace Townhom's Declaration of Party Wall Rights, Covenants, Restrictions and Easements shall read as follows:
