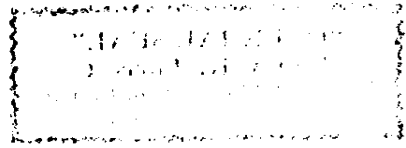


This Indenture, Made this 9th day of January, 1994,

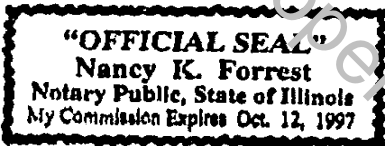
