LIMITED IRREVOCABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, Badger Capital Mortgage, Inc. (corporation) with its principal offices at 19 E. Irving Park Road, Roselle, IL 60172 County of DuPage and State of Illinois ("Principal") does hereby make, constitute and appoint American Residential Mortgage Corporation of the City of Oak Brook Terr. The power of attorney granted herein shall not be affected by any incapacity, dissolution, insolvency, liquidation, bankruptcy or death of the Principal.

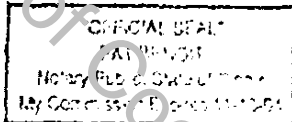
