If the Funds held by Lender exceed the amounts permitted to be held by applicable law, Lender shall account to Borrower for the excees Funds in accordance with the requirements of applicable law. If the amount of the Funds held by Lender at any time is not sufficient to pay the Eacrow Items when due, Lender may so notify Borrower in writing, and, in such case Borrower shall pay to Lender the amount necessary to make up the deficiency.
