KNOWN ALL MEN BY THESE PRESENTS, that COLE TAYLOR BANK, an Illinois Banking Corporation, for an in consideration of the payment of the sum of Ten and no/100 dollars (\$10.00) in hand paid, receipt of which is hereby acknowledged, does hereby REMISE, CONVEY, RELEASE AND QUIT CLAIM unto: MCL/Central Station Limited Partnership of the County of Cook and State of Illinois, all the right, title, interest claim or demand whatsoever that it may have acquired in, through or by a certain Construction Mortgage dated as of January 31, 1993, recorded in the Office of the Recorder of Deeds of Cook County, in the State of Illinois on February 9, 1993, Document Number 93107423 and Assignment of Rents dated as of January 31, 1993, and recorded on February 9, 1993, Document Number 93107424, and as amended from time to time, as to a portion of the premises therein described as follows, to wit:
