All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seized of the estate hereby convoyed and has the right to mortgage, grant and convoy the Property and that the Property is unencumbered, except for encumbrances of record.
