THIS BALLOON RIDER is made this thirty first day of January, 1994, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security instrument") of the same date given by the undersigned (the "Borrower") to secure the Borrower's Note to

First Home Mortgage Corporation

(the "Lender")

of the same date and covering the property described in the Security Instrument and located at:

1418 Huntington Drive Glenview, IL 60025 (Property Address)

The interest rate stated on the Note is called the "Note Rate." The date of the Note is called the "Note Date." I understand the Lender may transfer the Note, Security Instrument and this Rider. The Lender or anyone who takes the Note, the Security Instrument and this Rider by transfer and who is entitled to receive payments under the Note is called the "Note Holder,"

ADDITIONAL COVENANTS. In addition to the covenants and agreements in the Security Instrument, Borrower and Lender further covenant and agree as follows (despite anything to the contrary contained in the Security Instrument or the Note):

CONDUM PAAL RIGHT TO REFINANCE

At the maturity date of the Note and Security Instrument (the "Maturity Date"), I will be able to obtain a new loan ("New Loan") with a new Maturity Dite of February 1, 2024, and with an interest rate equal to the "New Note Rate" determined in accordance with Section 3 below if all the coronjons provided in Sections 2 and 5 below are met (the "Conditional Refinancing Option"). If those conditions are not met, I understand the the Note Holder is under no obligation to refinance or modify the Note, or to extend the Maturity Date, and that I will have to repay he Note from my own resources or find a lender willing to lend me the money to repay the Note.

CONDITIONS TO OPTION

If I want to exercise the Conditional Refinancing Option at maturity, certain conditions must be met as of the Maturity Date. These conditions are: (1) I must still be the ewner and occupant of the property subject to the Security Instrument (the "Property"); (2) I must be current in my monthly payment; and cannot have been more that 30 days fate on any of the 12 scheduled monthly payments immediately preceding the Maturity Date; (3) no non against the Property (except for taxes and special assessments not yet due and payable) other than that of the Security Instrument way exist; (4) the New Note Rate cannot be more than 5 percentage points above the Note Rute; and (5) I must make a written request to the Note Holder as provided in Section 5 below.

Provided the New Note Rate as calculated in Section 3 above is not present than 5 percentage points above the Note Rate and all other conditions required in Section 2 above are satisfied, the Note Holder will determine the amount of the monthly payment that will be sufficient to repay in full (a) the unpaid principal, plus (b) accrued but unpaid interest plus (c) all other sums I willowe under the Note and Security Instrument on the Maturity Date (assuming my monthly payments then are carrent, as required under Section 2 above), over the term of the New Note at the New Note rate in equal monthly payments. The recent of this calculation will be the amount of my new principal and interest payment every month until the New Note is fully paid.

EXERCISING THE CONDITIONAL REFINANCING OPTION
