WHEREAS, on the 30th day of March, 1993, an Annexaction Agreement was entered into by and between the Village of Glenview, a home rule nunicipality, and certain property owner, the Solid Waste Acency of Northern Cook County (SWANCC) owning property commonly known as the Wheeling Township Waste Transfer Station Site, which said Annexation Agreement is incorporated herein by reference; and

WHEREAL, pursuant to said Annexation Agreement of the 30th day of March, 1993, there was filed with the Clerk of the Village of Glenview a certain petition to annex to the said Village of Glenview, the said property hereinafter described; and

WHEREAS, the President and Board of Trustees of the Village of Glenview have independently determined that said property described in the aforesaid petition is not within the corporate limits of any municipality, that it is contiguous to the present village limits of the Village of Glenview, and that all property owners and more than 51% of the electors residing therein, have signed said petition as required by statute; and

WHEREAS, the President and Sound of Trustees of the Village of Glenview have determined that annexation of the said property is in the public interest and will promote the public health, safety and welfare of the Village of Glenview and its residents.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Glenview, Cock County, Illinois, that

Section 1: The facts and statements contained in the preamble to this Ordinance are found to be true and correct and area hereby adopted as part of this Ordinance.

Section 2: The property commonly known as the Wheeling Township Waste Transfer Station, and legally described as:

THAT PART OF THE SOUTH EAST QUARTER OF SECTION 36, TOWNSHIP 42
NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING FAST
OF THE CENTER LINE OF RIVER ROAD AND LYING WEST OF CENTER THREAD
OF DES PLAINES RIVER, EXCEPTING THEREFROM THE FOLLOWING TWO
TRACTS OF LAND DESCRIBED AS FOLLOWS:
BEGINNING AT THE POINT OF INTERSECTION OF CENTRAL ROAD AND
RIVER ROAD, SAID POINT BEING IN THE SOUTH LINE OF SAID SECTION
AND GALA FEFT WEST OF THE SOUTH FAST CORNER OF THE SOUTH FAST

RIVER ROAD, SAID POINT BEING IN THE SOUTH LINE OF SAID SECTION
AND 961.8 FEET WEST OF THE SOUTH EAST CORNER OF THE SOUTH EAST
QUARTER OF SAID SECTION; THENCE EASTERLY ALONG THE SOUTH LINE OF
SAID SECTION 930.0 FEET; THENCE NORTHERLY 783.0 FEET AT A 90
DEGREES ANGLE TO THE LAST DESCRIBED COURSE; THENCE WESTERLY 1133.0
FEET AT A 90 DEGREES ANGLE TO THE LAST DESCRIBED COURSE TO A POINT
IN THE CENTER LINE OF RIVER ROAD; THENCE SOUTHEASTERLY ALONG THE
CENTER LINE OF RIVER ROAD TO THE POINT OF BEGINNING AND ALSO EXCEPT:

OF SECTION 36, TOWNSHIP 42 NORTH, RANGE 12 EAST OF THE THIRD
PRINCIPAL MERIDIAN, A DISTANCE OF 31.80 FEET WEST OF THE SOUTH EAST
CORNER OF SAID SECTION; THENCE NORTH PERPENDICULAR TO SAID SOUTH
LINE OF SAID SECTION 36, A DISTANCE OF 783 FEET FOR A POINT OF
BEGINNING; THENCE WEST PERPENDICULAR TO THE LAST DESCRIBED COURSE,
DISTANCE OF 1120.06 FEET TO THE CENTER LINE OF RIVER ROAD AS DISTANCE OF 1120.06 FEET TO THE CENTER LINE OF RIVER ROAD AS
PAVED; THENCE NORTHWESTERLY ALONG THE CENTER LINE OF RIVER ROAD
