## NOTE MODIFICATION AGREEMENT

Lakeside Bank (the "Lender"), an Illinois banking corporation and the undersigned, Maria A. Cruto (the "Borrower") agree as follows:

- 1. The Lender presently owns and holds Borrower's note, dated November 18, 1993, and payable to the Lender in the sum of \$35,000.00 with a current Balance of \$35,000.00. The Note, Mortgage, and all other decuments evidencing or securing the Loan (the "Loan Documenci") are hereby incorporated herein by reference.
- 3. The Borrower has requested and the Lender has agreed that the terms of the Loan be modified. Accordingly, but Accordingly, but subject to the corditions hereinafter provided, the Note and Mortgage (and each of the other Loan Documents to the extent necessary to conform 'hereto) are hereby amended as follows:
  - The Maturity Date is extended (from February 18, 1994) to May 18, 1994.
- 4. The Borrower hereby varrants to the Lender that the title to the Premises and the priority of the Lien are in the same condition and subject to no exceptions other than as shown except that the real estate leves are currently paid and the Premises are free and clear from any mechanics' (or other) liens with respect to any construction work thereon.
- 5. The foregoing modification shall be effective as of the date hereof, all other provisions of the note shall remain in full force and effect; the execution hereof by the Borrower shall also constitute its direction upon the land trust to execute such documents reflecting this modification as the BANK may deem necessary or appropriate hereto.
