SUBORDINATION AGREEMENT

THIS AGREEMENT is made this 10th day of December, 1993.

WHEREAS, NLSB, AN ILLINOIS BANKING CORPORATION, has heretofore secured a loan with mortgage executed by ILONA W. KUCHTA, A MARRIED WOMAN, ("Mortgagor") dated August 1, 1991, and recorded August 30, 1991, recorded as Document Number 91449779, in the Cook County Recorder of Deeds Office.
