The variation gravted is as follows: To allow the petitioner to construct a 22 foot by 20 foot detached frame garage -- a 2-car garage -- resulting in an approximate 44.9% total coverage by buildings, which is an overage of 230 square feet, and 55.8% impermeable surface after removing the existing congrete patio -- making the overage 38 square feet, rather than the maximum coverage requirements of 40% and 50%, respectively, in paregraphs 8.2.9 and 7.14.2.2. of the Amended Zoning Ordinance.
