BXTENSION AGREEMENT

BLK GROVE TOWNSHIP) RANGE (1, BAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS

And,

WHEREAS, BANK is ine holder of said Note, Trust Deed and Assignment of Rents, and,

WHEREAS, Note came due on January 1, 1994, and

WHERBAS, the MORTGAGOR is requested that the due date of said Note and Trust Deed be extended, which request has been granted of the BANK, and

WHEREAS, Chicago Title and Trust Company, Trustee, under the Trust Dood described above has consented to this modification.
