

THAT PART OF THE EAST 1/2 OF THE NORTHWEST 1/4 OF SECTION 18, TOWNSHIP NORTH, RANGE 11, EAST OF THE THIRD PRINCIPAL MERIDIAN (EXCEPT THE SOUTH 27.15 FRET AS MEASURED ALONG THE WEST LINE THEREOF) DESCRIBED AS FOLLOWS: COMMENCING AT A POINT THAT 15 612.89 FEET EAST OF THE WEST LINE OF THE EAST 1/2 OF THE NORTHWEST 1/4 OF SFCTION 18, AFORESAID, MEASURED ON A LINE PARALLEL TO THE SOUTH LINE OF SAIL) SECTION AND 1428.22 FEET SOUTH OF THE NORTH LINE OF SAID SECTION, THENCE NORTHERLY PARALLEL WITH THE WEST LINE OF SAID SECTION 155.49 FEET; THENCE EAST ALONG A LINE PARALLEL WITH THE SOUTH LINE OF SAID SECTION 425.13 FEET EAST ()F THE POINT OF BEGINNING; THENCE WEST PARALLEL WITH THE SOUTH LINE OF SAID SECTION 488.13 FEET TO THE POINT OF BEGINNING (EXCEPTING THEREFROM THE NORTH 77.75 FEET THEREOF MEASURED ON THE WEST LINE OF SAID TRACT, CONVEYED TO MICHOLAS GING BY WARRANTY DEED DATED AUGUST 10, 1942 AND RECORDED SEPTEMBER 23, 1942 AS DOCUMENT 12,961,149, ALL IN COOK COUNTY, ILLINOIS.
