THIS LOAN IS NOT ASSUMABLE WITHOUT THE APPROVAL OF THE DEPARTMENT OF VETERANS AFFAIRS OR ITS AUTHORIZED AGENT.

This loan may be declared in mediately due and payable upon transfer of the property securing such loan to any transferce, unless the acceptability of the assumption of the loan is established pursuant to section 3714 of elapter 37, title 38, United States Code.

- A. Funding Fee. A fee equal to cae-calf of 1 percent of the balance of this loan as of the date of transfer of the property shall be payable at the time of transfer to the loan holder or its authorized agent, as trustee for the Department of Veteran's Affairs.
