- If the registered office is confided from one county to another, then the corporation must file with the recorder 4. of deeds of the new county a cortifled copy of the articles of incorporation and a certifled copy of the statement of change of registered office. Such certified copies may be obtained ONLY from the Secretary of State.
- 5. Any change of registered agent must be by resolution adopted by the board of directors. This statement must then be signed by the president (or vice president) and by the secretary (or an assistant secretary).
- The registered agent may report a change of the registered office of the corporation for which he or she is 6. OUNT CICRAS OFFICE registered agent. When the agent reports such a change, this statement must be signed by the registered agent.
