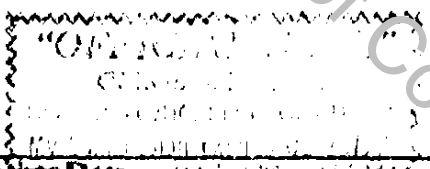

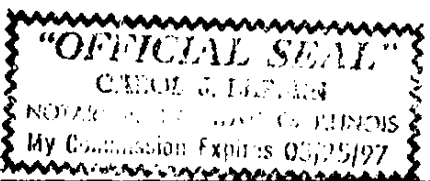

Part Thirteen Execution and Certification

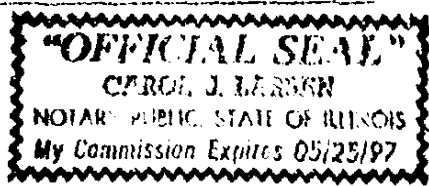
