"LEGAL DESCRIPTION"

#### Parcel 1:

Unit No. 106, as delineated on survey of that part of Lot 2 in Midlands Farms Subdivision of that part of the West 1/2 of the Northeast 1/4 of Section 29, Township 36 worth, Range 12, East of the Third Principal Meridian lying South of 5th Avenue described as follows: Commercing at the Southwest corner of said lot 2; thence North along the West line of said Lot a distance of 56.47 feet to a point; thence East perpendicular to the last described line a distance of 27.11 feet for a point of beginning; thence continuing East along the last described line 82.0 feet to a point; thence North perpendicular to the last described line a distance of 82.0 feet to a point that is 27.11 feet East of the West line of lot 2; thence South parallel to the West line of Lot 2 a distance of 153.0 feet to the point of beginning in Cook County, Illinois which survey is attached as Exhibit "A" to Declaration of Condominium ownership made by LaSalle Saxional Bank as Trustee under Trust Number 44283, recorded in the Office of the Recorder of Cook County, Illinois as document 22249107, in Cook County, Illinois, together with an undivided 2.09 percent interest in said parcel (excepting from said Parcel all the property and space comprising all the units as defined and set forth in said Declaration and survey), in Cook County, Illinois.
