

Rerecord to correct Maturity date

In consideration of the payment to COLUMBIA NATIONAL BANK OF CHICAGO, the owner and holder of the indebtedness described below, of a modification fee of \$00.00 receipt of which is hereby acknowledged, it is mutually agreed that the terms of repayment of said indebtedness be and they are hereby modified as herein provided:

The existing indebtedness is represented by a Note dated August 1, 1991, in the original principal amount of \$84,492.37 plus interest at the rate of P + 1% per annum with the final installment due and payable March 1, 1992. The Note is secured by a Mortgage and Assignment of Rents dated August 1, 1991 and recorded in the office of the Recorder of Cook County on September 17, 1991 as Document No. 91480389. The indebtedness was modified by Modification Agreement dated March 1, 1992 and recorded as Document No. 92318178 and further modified by Modification Agreement dated October 1, 1992 and recorded as Document No. 92748764.

The Note and Mortgage are hereby amended to provide that the unpaid balance of \$40,000.00 shall bear interest at the rate of P + 1% per annum and shall be paid in installments as follows:

Accrued interest on the 1st day of May, 1993 and on the 1st day of each succeeding month thereafter for 47 successive months and a \$5,000.00 principal reduction due every 6th month beginning 10/1/93 with a final payment of unpaid balance plus accrued interest on the 1st day of April, 1993.

All other terms, provisions and conditions of the Note and Mortgage and any and all other security instruments and supporting documents of any nature shall remain unchanged in every respect and are hereby ratified and confirmed.

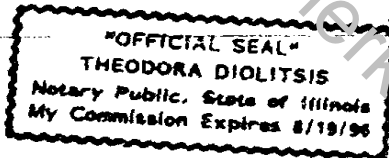
