THIS MORTGAGE ("Mortgage") is made this day of between Mortgagor, Peter A. Vilips single never married (herein "you," "your" or "yours") and the Mortgagee, Citibank, Federal Savings Bunk, a corporation organized and existing under the laws of the United States, whose address is 500 West Madison Stree!, Chicago, Illinois 60661 (herein "we," "us" or "our").

WHEREAS, Peter A. Villps is (are) indebted to us pursuant to a Preferred Line Account Agreement ("Agreement") of even date hereof, in the principal sum of U.S. \$ 10,000.00, (Borrower's "Credit Limit") or so much of such principal as may be advanced and outstanding, with interest thereon. The Agreement provides for advances to be made for seven (7) years from the date hereof (the "draw period"). We may, in our sole discretion, extend the draw period for an additional seven (7) years. The draw period will be followed by an additional period of seven (7) years (the "repayment period"). The Agreement provides for periodic monthly installment payments of (a) principal of 1/84th of the principal bulance outstanding and unpaid as of (i) the date of the most (ecros) billing statement to you thereunder for billing cycles beginning during the draw period or (ii) the beginning of the first day of the repayment period for any billing cycle beginning during the repayment period; and (b) interest, optional credit life and/or (scability insurance premiums, and miscellaneous fees and charges until the end of the repayment period; all such sums, if not somet paid, being due and payable fourteen (14) years from the date hereof, or, if we have extended the draw period, twenty one (21) years from the date hereof, the ("Maturity Date").

You, unless you are an litinois land trust, warrant and will defend generally the title to the Property against all cleims and demands, subject to any encumbrances of

Covenants. You and we covenant and agree as follows:

1. Payment of Principal and Interest. You shall promptly pay when die by the terms of the Agreement the principal of and interest accrued on the indebtedness evidenced by the Agreement, together with any other fees, charges or premiums imposed by the Agreement or by this Mortgage.

2. Line of Credit Loan. This Mortgage secures a Line of Credit Loan Agreement, You will enjoy access to that Line of Credit during the first eighty-four (84) hilling cycles or, if we extend the draw period, in first one hundred sixty-eight (168) billing cycles.

3. Agreed Periodic Payments. During the term hereof, you agree to pay on or before the payment due date shown on ... each periodic Billing Statement the Minimum Payment Due for that Billing Cycle (each Billing Cycle, will be approximately one month). The payment due date for each Billing Cycle is approximately twenty-live (25) days after the close of the Billing Cycle.

If, on the Maturity Date, you still owe amounts under the Agreement, you will pay those amounts in full on the Maturity

4. Finance Charges. You agree to pay interest (a 'Finance Charge') on the Outstanding Principal Balanco of your Preferred Line Account as determined by the Agreement. The rate of interest ('Annual Percentage Rate') may vary monthly but will not exceed 25.0% per annum.

5. Application of Payments. Onless applicable law provides otherwise, all payments received by us under the Agreement and this Morigage shall be applied as provided in the Agreement. Charges incurred pursuant to paragraph 7 hereof will be treated as Finance Charges for purposes of application of payments only.

6. Charges: Liens. You shall pay all taxes, assessments, charges, lines and impositions attributable to the Property which may attain priority over this Mortgage, and leasehold payments or grounds rents, if any. You shall promptly furnish to us receipts evidencing these payments.

7. Protection of Our Rights in the Property; Mortgage Insurance, It you fall to perform the coverants and agreements contained in this Mortgage, or there is a legal proceeding that may significantly affect our rights in the property (such as a proceeding in bankruptcy, probate, for condemnation or to enforce laws or Ragulations), then we may do and pay for whatever is necessary to protect the value of the Property and our rights in the Property. We shall not be required to commence proceedings against any successor in interest or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Morigage by reason of any demand made by the original Account Holder or Account Holder's successors in interest. Any forebearance by us in exercising any right or remedy shall not be a waiver of or

preclude the exercise of any right or remedy.

Successor and Assigns Bound; Joint and Several Liability; Co-Signers. The covenants and agreements of this Mortgage shall bind and benefit the successors and assigns of you and us, subject to the provisions of paragraph 12. Your covenants and agreements shall be joint and several. Any Mortgagor who co-signs this Mortgage but does not execute the Agreement: (a) is co-signing this Mortgage only to mortgage, grant and convey that Mortgagor's Interest in the Property under the terms of this Mortgage; (b) is not personally obligated to pay the sums secured by this Mortgage; (c) does not have secess to the Line of Credit; and (d) agrees that we and any other Mortgagor may agree to extend, modify, forebear or make any accommodations with regard to the terms of this Mortgage or the Agreement without that Mortgagor's consent. 10. Prior Mortgages. You covenant and agree to comply with all of the terms and conditions and covenants of any mortgage, trust deed or similar security instrument affecting the Property which has or may have priority over this Mortgage, including specifically, but not limited to, timely making the payments of principal and interest due thereunder. Your fallure to make such payments or keep such terms, conditions and coverants as provided for in such prior mortgages, trust deeds or security agreements shall constitute a default under this Mortgage, and we may invoke the remedies specified in paragraph 14

hereof.

11. Default.

(a) The occurrence of any of the following events shall constitute a default by you under this Mortgage: (1) failure to pay when due any sum of money due under the Agreement or pursuant to this Mortgage; (2) your action or inaction adversely affects our security for the Agreement or any right we may have in that security; (3) you gave or give us any false or materially misleading information in connection with any Loan to you or in your application for the Preferred Line Account (4) title to

your home, the Property a Consterred as more fully described in paragraph 12 below; or (5) any of you die

(b) It you are in details ander the Agreement or this Mortgage, or if you are an officer subject to regulation "O" as published by the Federal Reserve Paurd, we may terminate your Preferred Line Account and require you to pay immediately the principal balance outstanding, any and all interest you may ove on that amount, together with all other fees, costs or premiums charged to your account the principal balance outstanding under the Agreement after default shall continue to accrue interest until paid at the rate provided for in the Agreement will no dofault had occurred. In addition to the tight to terminate your Preferred Line Account up. Cectare all sums immediately due and owing under the Agreement, in the event of a default, we shall have the right to refuse to make additional Loans to you under the Agreement (reduce your Credit Limit). If we refuse to make additional Loans to you after default, but do not terminate your account, you must notify us in writing if you would like to obtain further Loans and can demonstrate that the condition that led to the default no longer exists.

12. Transfer of the Property. It all or any part of the Property, or an interest therein is sold or transferred by you, or if the beneficial interest, or any part thereof, in any hard trest holding title to the Property is assigned, sold or transferred, or if you or the title holding trust enter into Articles of Ago, sment for Doed or any agreement for Installment sale of the Property or the beneficial interest in the title holding land trist, without our prior written consent, excluding: (a) the creation of a purchase money security interest for household appliance; (b) a transfer by devise, descent or by operation of law upon the death of a joint tenant; or (c) the grant of any leasehold interest of three (3) years or less not containing an option to purchase, we may, at our option, declare all sums secured by this Mortgag; to be immediately due and payable.

13. Right to Reduce Line of Credit. We may reduce your Credit Limit or suspend your credit privileges (refuse to make additional Loans) if: (a) the value of the Property drops significantly below the appraised value upon which the Agreement was based; (b) a material change in your financial circumation is gives us reason to beffeve that you will not be able to make the required payments; (c) governmental action precludes us from charging the Annual Percentage Rate permitted by the Agreement or governmental action adversely affects our lien priority such that the value of our security interest fails below 120% of your Credit Limit; (d) we are notified by our Regulatory Agency that condinuing to make Loans constitutes an unsafe and unsound practice; or (e) you are in default of any material obligation under the Agreement. If we refuse to make further Loans to you, but do not terminate your Preferred Line Account, you must not be in writing if you would like to obtain further Loans and can demonstrate that the conditions that gave us the right to refuse to make further Loans has changed.

14. Acceleration; Remedies. Upon a Default by you under this Mortgage, we at our option, may require immediate payment in full of all sums secured by this Mortgage without further demand and nay foreclose this Mortgage by judicial proceeding. We shall be entitled to collect all expenses incurred in pursuing the remedies provided in this paragraph 14, including, but not limited to, reasonable attorneys' fees and costs of title evidence.

15. Waiver of Homestead. You waive all right of homestead exemption in the property.
